Point 6c: Recycling schemes

- Recycling schemes are assigned a recycling scheme number ('RSN');
- 1st Step: Verification of the 92 Recycling schemes dossier received till today, with the recyclers in order to verify (second week of May) :
 - The definition of the recycling scheme as indicated under article 2 (2.15) 'recycling scheme' means an arrangement between legal entities to manage the use, separate collection and recycling of plastic materials and articles with the objective to limit or prevent their contamination in order to facilitate their recycling;
 - 2. The requirements as established for an operation of the recycling schemes under Article 9 (1) a single legal entity shall act as the manager of a recycling scheme, and shall be responsible for the overall functioning of the recycling scheme.
 - 3. The recycling scheme shall be set up in accordance with the specific requirements applicable to the applied suitable recycling technology as laid down in table 1 in Annex I and, where applicable, with the authorisation of the applied recycling process
- 2nd Step: Evaluation of the dossiers COM & updating the Register with the RSN codes (May to
