**Section B Draft(s) presented for an opinion**

- B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Commission Implementing Decision (EU) 2020/1729 as regards monitoring of methicillin-resistant *Staphylococcus aureus* (MRSA) in fattening pigs (MP)

The purpose of this initiative is to update the EU legislation on the monitoring and reporting of antimicrobial resistance (AMR) in food and food-producing animals in order to monitor MRSA (baseline survey) in fattening pigs in 2025 based on EFSA technical specifications.

- C.01** Exchange of views of the Committee on a draft Commission Implementing Regulation amending Commission Implementing Regulation (EU) 2020/2235 of 16 December 2020 laying down rules for the application of Regulations (EU) 2016/429 and (EU) 2017/625 of the European Parliament and of the Council as regards model animal health certificates, model official certificates and model animal health/official certificates, for the entry into the Union and movements within the Union of consignments of certain categories of animals and goods, official certification regarding such certificates and repealing Regulation (EC) No 599/2004, Implementing Regulations (EU) No 636/2014 and (EU) 2019/628, Directive 98/68/EC and Decisions 2000/572/EC, 2003/779/EC and 2007/240/EC (PHS)

The proposed Regulation intends to:

- correct Article 26 of Implementing Regulation (EU) 2020/2235 in order to reflect the amendments introduced by Implementing Regulation (EU) 2022/2504 to the model official certificate for the entry into the Union of highly refined products as described in Section XVI of Annex III to Regulation (EC) No 853/2004, intended for human consumption set out in Chapter 46 of Annex III to that Implementing Regulation;
- correct the titles of model certificates in Annex IV to Implementing Regulation (EU) 2020/2235 and corresponding Articles 31 and 32 in order to align them with the relevant provisions of Delegated Regulation (EU) 2019/624;
- align wording in model certificate set out in Chapter 2 of Annex IV Implementing Regulation (EU) 2020/2235 with relevant provisions of Article 6(2) of Delegated Regulation (EU) 2019/624.
