Finland has informed the Commission that a decision to withdraw BKD from the list of diseases which shall be controlled and eradicated on mandatory basis is made and which will enter in force from 1 December 2014. As a consequence Finland should be deleted from the list of Member States with a national eradication for BKD in Annex II to Commission Decision 2010/221/EU.
