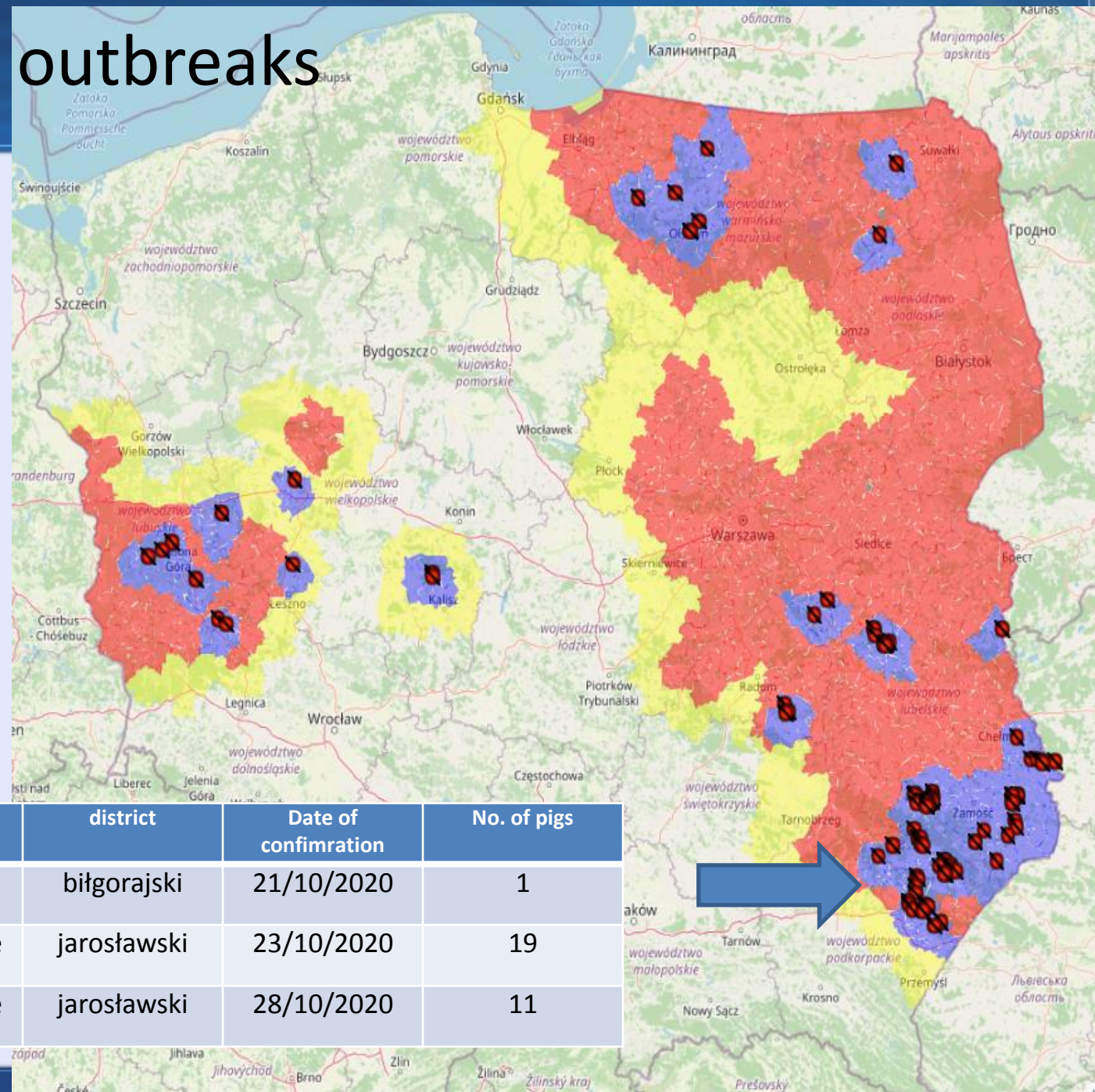

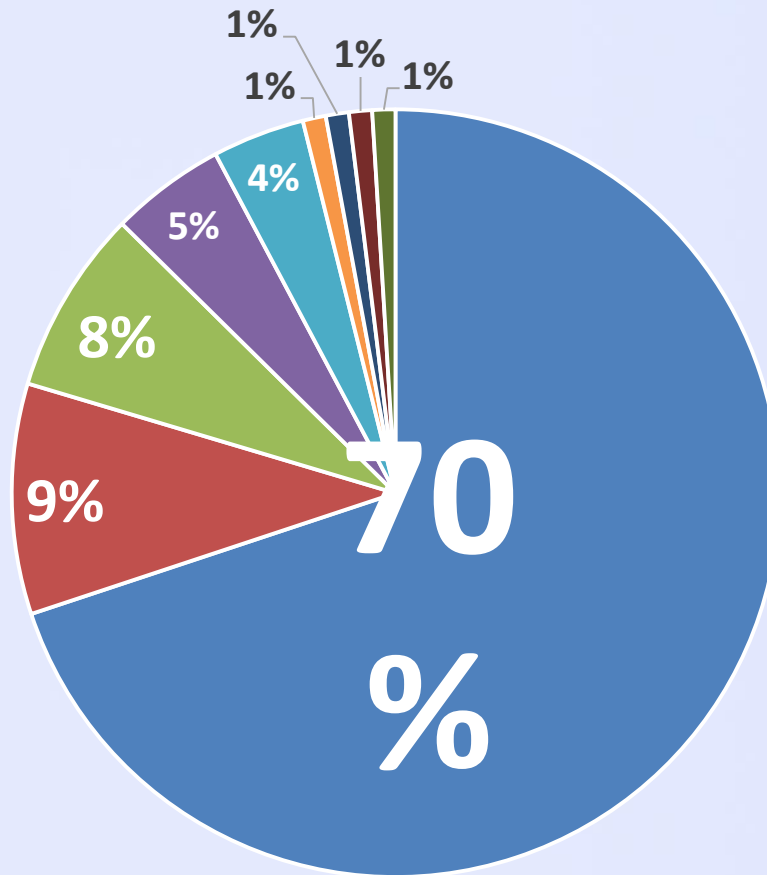

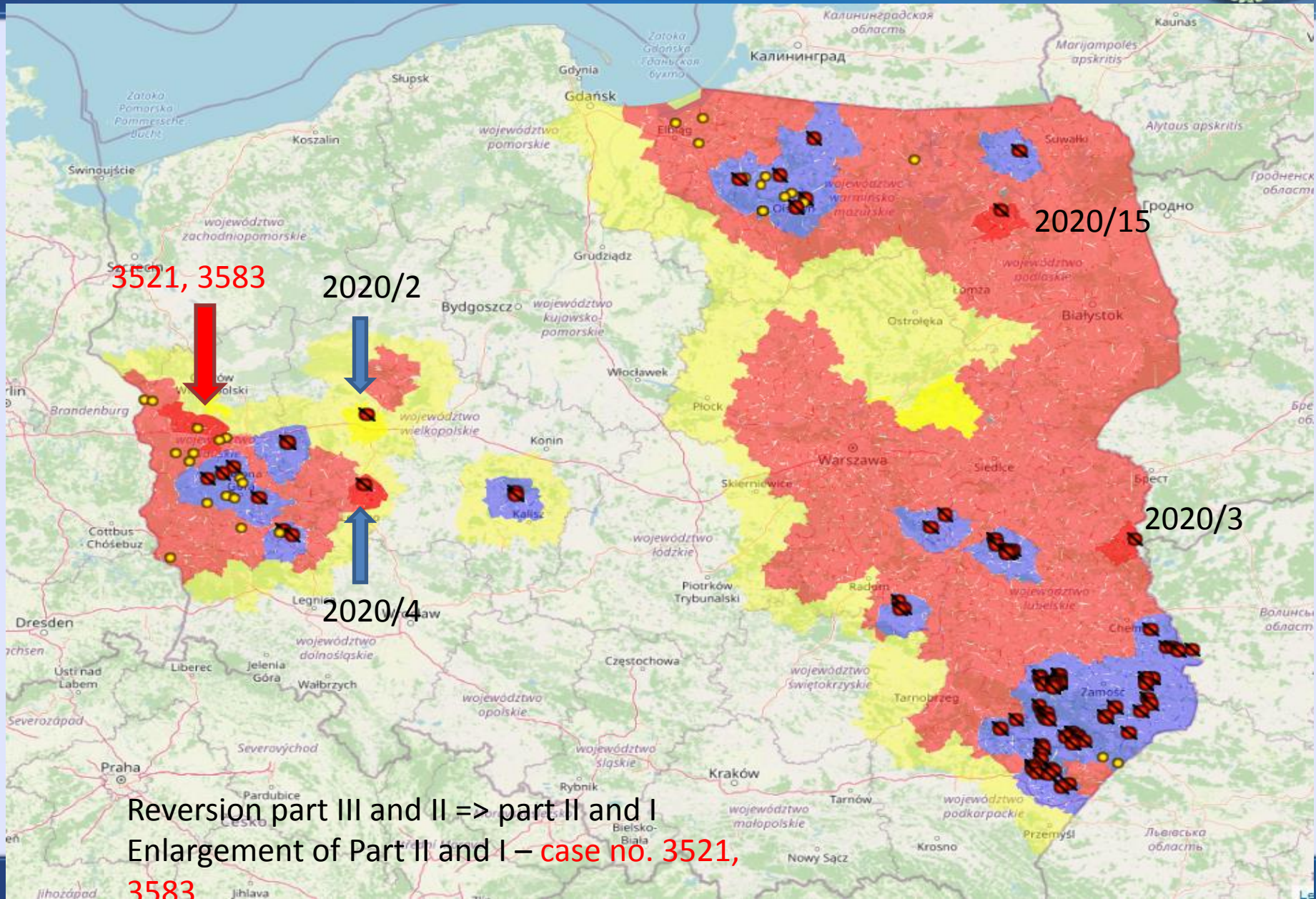

National Action plans on wild boar management in the context of ASF prevention



- The document „Actions to eradication of ASF in wild boar” has been developed, which includes provisions of „Strategic approach (...)” and WB management.
- Document was sent to Ministry of Agriculture and it will be the subject of inter-ministerial consultations with the Ministry of the Environment, responsible for wild fauna management;

National Action plans on wild boar management in the context of ASF prevention



- Some elements of „Strategic approach” were already introduced into national legislation, i.e. fencing of the area where ASF is present, fencing of public roads.
- Some parts concerning rules of hunting, including collective hunting in different areas were already sent to local vet authorities;
- Actions taken by the GVI allowed for the implementation of the „Strategic approach”, taking into account national law, the scope of competence of the Veterinary Inspection, which allows for its implementation by the end of this year
