The draft Implementing Regulation amends notes for the completion of model certificates for the entry into the Union of animals, products of animal origin, composite products, germinal products, animal by-products, sprouts for human consumption and seeds intended for the production of sprouts for human consumption and model certificates for the entry into the Union of consignments of certain categories of animals and goods intended for human consumption in order to, i.e.: reflect new animal health requirements introduced to Commission Delegated Regulation (EU) 2020/692 by Delegated Regulation (EU) 2023/119; update references to new legislation regarding

residues and public health requirements for the entry into the Union of certain categories of animals and goods for human consumption, simplify and harmonise certain descriptive elements relating to the establishments from which or in which consignment is dispatched, obtained or prepared; align and clarify BSE attestations; and clarify and make consistent the wording of certain requirements, notes and footnotes.
