Bluetongue – Situation in Belgium


- 5 June 2023: officially free of Bluetongue (BT)
- Loss of BT-free status:
 - 6 October 2023: suspicion of BTV in one sheep on a small holding in Merksplas (PCR positive after diagnostic examination):
 - Fever
 - Respiratory symptoms
 - Stiffness
 - Crusts on the nose
 - Dried nasal discharge
 - The sheep is now cured of its symptoms
 - 9 October 2023: confirmation of BTV serotype 3, same serotype as in the Netherlands
 - 18 October 2023: No additional cases of BTV



Bluetongue – Situation in Belgium

150 km zone

Entire Belgian territory
demarcated as restricted zone
→ no restrictions on national trade



Bluetongue – Situation in Belgium

- Consequences
 - No restriction measures on affected farms
 - Major impact on movement of live ruminants, semen and embryos to other Member States
 - No vaccine available
 - No vector-free period
 - No approved eradication programme
 - The conditions for "safe animals" are not met
 - ➔ Only specific derogations depending on Member State of destination
- Future:
 - Further spread of the virus is expected, although the temperature drops
 - Vaccination: collaboration with Germany and the Netherlands to obtain a vaccine as soon as possible
