Action plan and analysis of the annual reports for 2010 on the protection of animals during transport (1/2005/EC)

2010

Serious infringements, when animal welfare penalty was imposed:

- The road vehicle was not cleaned and disinfected;
- The vehicle was not approved by the competent authority and 1.1.1. point (b) of Chapter II. Of Reg. 1/2005 was violated (protect the animals from inclement weather, extreme temperatures and adverse changes in climatic conditions);
- Violation of Annex I, Chapter III, point 1.11. – Bovine animals were tied by the horns during transport;
- Loading of the animals to another vehicle during the journey, amending of the journey log after the journey.
- Missing authorization of the transporter, vehicle; missing certificate of the driver;
- The transporter was authorized but the copy of the authorization could not have been presented by the attendant/driver.

Other official measures: oral and written warning, withdrawal of the approval of the vehicle, food chain control fine.

Some feedbacks were received from other Member States' competent authorities, which inform us about that some transport companies did not send back the journey logs.

Action plan

Due to the lack of serious infringements - it does not seem necessary to take any special, national actions.
