SUBJECT: PHOSPHOLIPID PRODUCT MEMREEPLUS-40P CONTAINING PHOSPHATIDYL-SERINE AND PHOSPHATIDIC ACID

This letter is to inform you of the results of the review procedure carried out pursuant to Articles 4 and 6 of Regulation (EC) No 258/97 on the novel food application "MemreePlusTM-40P phosphatidylserine and phosphatidic acid standardised phospholipid powder product" submitted to the Finnish Food Safety Authority Evira.

Lipogen Products (9000) Ltd submitted on 25 January 2016 to Evira an application concerning a novel food as referred to in Regulation (EC) No 258/97. The application concerned the use of phospholipid product MemreeplusTM-40P containing phosphatidylserine and phosphatidic acid as a novel food ingredient.

Evira submitted the application on 19 February 2016 to the Finnish Novel Food Board that carries out food assessments for performance of the initial assessment referred to in Article 6. The Novel Food Board submitted to Evira on 22 April 2016 the initial assessment report, which stated that MemreePlusTM_40P as a novel food ingredient fulfils the conditions laid down in Article 3(1) in the Novel Food Regulation (EC) No 258/97 in the uses and at levels proposed by the application. The Board further stated that as the product may be expected to involve problems for consumers suffering from soy allergies, the labelling of foods containing MemreePlusTM_40P derived from soy lecithin should show the information to the consumers that the source of the product is soy.

The Commission forwarded the initial assessment report to all Member States on 3 August 2016. No reasoned objections were presented within the period of 60 days confirmed in Regulation (EC) No 258/97, Article 6(4) on the use of phospholipid product Memreeplus[™]-40P containing phosphatidylserine and phosphatidic acid as a novel food ingredient as presented in the application. Germany, the United Kingdom and the Netherlands raised questions which were replied by the applicant and the Novel Food Board in a manner that satisfied the Member States concerned.

Based on the aforesaid, phospholipid product MemreeplusTM-40P containing phosphatidylserine and phosphatidic acid meets the requirements laid down in Regulation (EC) No 258/97, Article 3(1) and the placing on the market of the product concerned can be authorised on the following conditions:

1) Product specification:

As concerns foods for special medical purposes and total diet replacements, the MemreePlusTM-40P product is to be used in accordance with the conditions laid down in the special legislation concerning these products (Regulation (EU) No 609/2013 of the European Parliament and of the Council).

- 3) The product is not intended to be marketed to pregnant or breast-feeding women.
- 4) The labelling of foods containing the product shall indicate that the source of the product is soy, for example "soy phosphatidylserine and phosphatidic acid".

Lipogen Products (9000) Ltd. is authorised to place on the market phospholipid product Memreeplus[™]-40P containing phosphatidylserine and phosphatidic acid for use as a novel food ingredient according to the above presentations.
