Outbreaks HPAI H5N1 since 06/07 April 2022 (after last PAFF meeting)

16 outbreaks in poultry:

- 7 outbreaks in Galliformes
- 7 outbreaks in Waterfowl
- 1 backyard



- Restriction zones established : 3 km zone (1 fattening farm with 4900 mullard duck ; 10 km (2 fattening farm with 40 000 mullard in total);
- Restrictions in 10-km zones are still ongoing



- Official visits, clinical examinations and sampling in the industrial farms in 3 km zone, sampling in case of suspicion in 10 km zone are concluded with favorable outcomes and no further outbreaks are confirmed




- Restriction zones established in relation with HPAI (P) : 3 km zone (one non-operating broiler holding); 10 km (broiler holding, one small laying hens holding);

- Restriction zones established in relation with HPAI (P) : 3 km (only affected holdings); 10 km (2 laying hen farms (9700), breeding hen (3600));
- Official visits, clinical examinations and sampling in the industrial farms in the restriction zones.

Further measures applied:

- Epidemiological investigations have just started. Consignments of hatching eggs during the incubation period were sent to Greece and Hungary (CAs have been notified);
- > Ban for outdoor poultry keeping;
- Ban for poultry market ;
- > Enhanced biosecurity measures in the poultry farms in entire country;
- > Enhanced surveillance in wild birds in entire country;
- Further restriction zones to be established (under consideration);
