Surveillance of ASF – Greece 2020

<u>data until 10.06.2020</u>

Passive surveillance

✓ 4 wild boars found dead

✓ 44 domestic pigs found dead including clinical suspicions

Active surveillance

✓ 15 wild boars hunted (during hunting period)

 ✓ 34 wild boars hunted by the organized hunting missions (gamekeepers & hunters & forestry officers)

✓ 2606 domestic pigs (including surveillance in Protection-Surveillance Zone following ASF outbreak)

African Swine Fever –Passive/active surveillance 2019-2020 (10.06.2020)



□ Laboratory analysis was completed early in the afternoon on 05.02.2020




Protection zone ~ 35km Surveillance zone ~ 65km

Actions taken following ASF outbreak in Greece Protection Zone

- All pig farms:
- ✓ have been clinically testing
- sampling has been performed in the total of the farms in this zone (167 samples) according to the provisions of Dir. 60/2002 (art 10) and Dec. 2003/422/EC after the 23th of March (45 days following the completion of preliminary cleansing and disinfection of the affected farm) and the analytical lab results provided were negative

Actions taken following ASF outbreak in Greece Surveillance Zone

- Clinical examinations of all pig farms as well as samplings and laboratory testing in a number of these farms (Dir. 60/2002 & Dec. 2003/422/EC), have been completed in Surveillance Zone with negative results ,after the 18th of March (40 days following the completion of preliminary cleansing and disinfection of the affected farm)
- More than 50%-61% (depending on the Municipality) of the farms in the part of Surveillance Zone in Serres Regional Unit had been sampled (673 samples) according to the provisions of Dec. 2003/422/EC and laboratory tested
- In the part of the Surveillance Zone in Thessaloniki Regional Unit, samples by 311 animals in total derived by 13 farms were tested and found negative

Passive surveillance before lifting measures: ALL NEGATIVE

- Serres RU: samples derived by 11 dead pigs following the detection of the case (05.02.2020)
- **Thessaloniki RU**: samples derived by 17 dead pigs following the detection of the case (05.02.2020)
- Hunted and/or dead wild boars in these areas: Negative

Measures lifting

- Measures lifted in Thessaloniki RU (Surveillance Zone) on 08.04.2020
- Measures lifted in Serres RU (Protection and Surveillance Zone) on 15.04.2020

Controls in commercial pig farms/backyard farms

Controls – clinical tests – biosecurity (seasonal staff recruited for the needs of ASF preventive measures)

first semester 2020

Preparatory Actions

□ Staff recruitment: Request for recruitment of seasonal veterinarians for the prevention and eradication (if needed) of ASF

During the previous year, seasonal vets have been recruited since September-October 2019 in high risk Regional Units (Regions: East Macedonia and Thrace,

Central Macedonia, West Macedonia, Ipiros)

Main tasks: Visits to all backyard pig farms-registration/identification controls/biosecurity checks, clinical examinations, awareness (pig farmers-hunters)

□ Controls: Intensification of controls of backyard farms, commercial farms, slaughterhouses, entrance of vehicles carrying live animals, systems of cleansing and disinfection in farms and slaughterhouses

Supplies: Field consumables will be soon delivered to RUs

Measures relating to domestic pigs (1)

- Ministerial Decision (No.758/68204/18.02.2020 (GG 730B/09.03.2020) foreseeing measures related to:
- the management of pigs without owner or non registered pig farms
 Culling and disposal of carcasses with burial
- the non commercial farms in protection/surveillance established zones

Culling and disposal of carcasses with burial

the non commercial as well as the systematic (commercial) farms in the entire country

Immediate slaughter

□ minimum biosecurity requirements at the different farms' categories

Measures relating to domestic pigs (2)

- Circulars issued within first semester 2020 related to:
- > Animal movements/veterinary controls and documentation required
- Decontamination of vehicles
- Passive surveillance in domestic pigs and wild boars
- Safe disposal of animal by products (dead pigs)
- Pig farms registration

Measures relating to wild boars

Wild boar population management:

- ✓ Official request addressed to the Ministry of Environment and Energy regarding modifications of hunting rules – wild boars population reduction
- ✓ Action plan for wild boars management preparation will be prepared up to the end of the year
- A new Joint Ministerial Decision is to be issued during the following period:
- ✓ Increases in the remuneration of hunters for passive surveillance samples notification, sampling, carcasses safe disposal, sampling
- ✓ Remuneration for hunters for reduction of female adult wild boars
- ✓ Involvement of citizens for the notification of wild boars found dead
