ASF cases in wild boar in 2019

- ✓ 1 January 31 December 2018:
 2243 ASF cases in wild boar
- ✓ 1 January 10 May 2019: 1037 cases
 ✓ Since last PAFF (11.04.2019): 173



ASF outbreaks in pigs:

✓ No more outbreak since 2019/1 which was confirmed on <u>29 January 2019</u>

Lubelskie voivodship:


new Part II due to cases no. 2019/844 and

- ✓ new Part II:

municipalities of Gorzków and Stary Zamość


✓ new Part I:

municipality of Sułów and part of municipality of Szczebrzeszyn




Reverting of the area listed in Part II into Part I:

- Podlaskie voivodship:
- Part II -> Part I: municipality of Śniadowo and part of municipality of Zambrów
- Arguments:
- ✓ 1 ASF case in WB was confirmed
- on 6 March 2018 on the territory of municipality of Śniadowo (female killed due to car accident).
- ✓ No more cases up to now
- (174 WB have been tested for period January 2018-March2019)
- ✓ The nearest case located in the municipality of Wizna, about 16 km away, was confirmed on 10 August 2018 (no more cases since that)




Reverting of the area listed in Part III into Part II:

- > Warmińsko Mazurskie voivodship:
- Part III -> Part II: municipality of Banie Mazurskie,
 part of municipalities of Gołdap and Kowale Oleckie
- Arguments:
- ✓ 1 ASF outbreaks in pigs which was confirmed on 29 January 2019
- ✓ Over than 3 months without outbreaks in pigs
- ✓ Areas with ASF cases in WB



Reverting of the area listed in Part III into Part I:


- Podkarpackie voivodship:
- Part III -> Part I: municipality of Cieszanów
- Arguments:
- ✓ 8 ASF outbreaks in pigs were confirmed in August 2018(1 primary and 7 secondary outbreaks).
- ✓ Before these outbreaks free area with 67 holdings and 5431 pigs, including 35 holdings keeping up to 10 pigs
- ✓ Killing of pigs in all contact holdings within.
- the established protection area (24 holdings with 491 pigs).
- ✓ There has not been pig's repopulation yet.



- ✓ The distance from this area to the nearest ASF case in the neighboring voivodship is over than 60 km.
- ✓ Since August 2018 to April 2019 in lubaczowski district there 850 samples obtained from wild boar have been laboratory tested with negative results.

Reverting of the area listed in Part III into Part I:

- Podkarpackie voivodship:
- Part III -> Part I: municipality of Cieszanów
- Measures taken in this area to avoid re-introduction of the disease on the base of epidemiological inquiries:
 ✓ Notification to the law enforcement authorities in relation to the primary outbreak, due to the hypotesis that farmer could transmit ASV virus by contaminated materials or goods.
 However the investigation had to be suspended due to the farmer's death.



- Awareness campaign addressed to pig farmers and other industries related to pig breeding (i.e. inseminators, transporters).
- ✓ Awareness campaign concerning biosecurity measures addressed to hunters.
- ✓ Controls of biosecurity rules in farms.
