

MAP - Epidemiological situation







Appropriate actions have been taken in accordance with CDR 687/2020: the pigs were culled, the disinfection of the units was carried out, the carcasses were rendered and restriction zones have been established.




MAP - Commercial farms outbreaks



RO ASF - Request for derogation (1)

<u>Epidemiological situation in</u> <u>Suceava County</u>

- ► Three active outbreaks in backyard farms;
- ► All measures have been implemented acc. CDR 2020/687 on affected units and restriction zones







RO ASF - Request for derogation (2) Information on blocked commercial unit

Big Commercial farm bloked in surveillance zone:

- ▶ 23.632 fattening pigs, of which 7.000 at delivery weight;
- complies with biosecurity requirements imposed by legislation in force;
- ▶ implements an intensive ASF surveillance program, with negative results.

We kindly request the approval for the delivery of a number of 7.000 fattening pigs from the unit to a slaughterhouse for slaughter and that the meat not to be subject to risk-mitigating treatment.

RO ASF - Request for derogation (3)

Additional guarantees in case of transport authorization

Big Commercial farm bloked in surveillance zone:

- official control on biosecurity took place;
- passive surveillance in place, with negative results;
- ▶ In the event of authorization of this transport, the embarkation will be carried out under official control
- ▶ 72 hours prior to authorization, EDTA blood samples will be randomly collected for virological examination. The minimum number of samples to be taken must enable a virus prevalence of 20% to be detected with a confidence level of 95% in the batch to be delivered:
- During boarding, the official veterinary will inspect the animals and conduct a clinical examination of the batch to be delivered. The minimum number of pigs to be clinically examined must enable a prevalence of the disease to be detected of 20% with a confidence level of 95%, for each transport.

We consider that the competent authority has assessed the risks arising from this authorization and the assessment shows that the risk of the spread of African swine fever is negligible.
