The draft Implementing Regulation clarifies the animal health requirements depending of the milk origin in the model animal health/official certificates for the entry into the Union of respectively, raw milk intended for human consumption (MODEL MILK-RM); dairy products intended for human consumption derived from raw milk or that are not required to undergo a specific risk-mitigating treatment (MODEL MILK-RMP/NT); and dairy products intended for human consumption that are required to undergo a pasteurisation treatment (MODEL DAIRY-PRODUCTS-PT) set out in Chapters 33, 34 and 35 of Annex III to Implementing Regulation (EU) 2020/2235.
