1. Introduction

This work programme includes implementing measures for the year 2017. On the basis of the objectives given, the distribution of budget for the procurements implemented in direct management is the following, for a total amount of $12\,258\,000\,$ €.

2. PROCUREMENT

2.1. IT PROJECTS TO SUPPORT THE FUNCTIONING OF THE RAPID ALERT SYSTEM FOR FOOD AND FEED (RASFF), REGISTER OF NUTRITION AND HEALTH CLAIMS, FOOD SYSTEM TO SUPPORT ADDITIVES, FLAVOURINGS, ENZYMES FOOD CONTACT MATERIALS, RECYCLING PROCESS. IT PROJECTS IN THE AREA OF NOVEL FOODS, FOOD LABELLING AND FOOD WASTE, PILOT PORTAL FOR AUTHORISATION SYSTEM

The actions to be financed under this section target the maintenance and further development of the existing Generic Rapid Alert System and the Rapid Alert System for Food and Feed, the set-up of the Register of authorised Food Contact Materials, Novel Food, GM food and feed, GMOs, Flavourings and Enzymes, the development of a new version of the Novel Foods register, and the maintenance of the existing Union register for nutrition and health claims.

The action to be financed under this budget aims to maintain and improve the implementation and the maintenance of the Rapid Alert System for Food and Feed (thereafter 'RASFF'), and the administrative collaboration system. The use of the same IT platform by the various alert systems managed by the Commission facilitates the exchange of information between these systems and improves the manageability from an IT perspective.

The RASFF IT application needs to be maintained and developed further on two main accounts:

- (a) regional levels in countries to better accommodate the large Member States or those Member States with federal or non-federal models and
- (b) building and maintaining external links with other information systems in the food controls [e.g. Trade Control and Expert System (TRACES)] administrative co-operation areas.

In order to have an informed view on non-authorised substances and support the RASFF, it is necessary to maintain registers with authorised substances (food contact materials, novel food, GM food and feed, GMOs, flavourings, enzymes and nutrition and health claims).

The capacity to deal with tracking of incriminated foodstuffs during multinational investigations of outbreaks of foodborne pathogens has to be provided with an extra tool for tracing/back & forward exercises.

- Maintenance and improvement of the country regional level and functionality to RASFF: 425 000 €;
- Development of functionality related to the path of food products in relation to RASFF: 200 000 €;
- Additional development to improve the performance of the RASFF sector application, including specifications for external systems' links: 430 000 €;
- Evolution and maintenance of a Union Register for nutrition and health claims made on food: 120 000 €;
- Maintenance of NF-net and NF net web (system supporting Novel Food Network and its webpage): 73 000 €;
- Establish a common basis for Food systems supporting the domains of Food Contact Materials, recycling process, Additives, Flavourings and Enzymes: 364 000 €;
- Creation of a Food labelling Information system: 300 000 €;
- Novel Foods development of a new version of the register (based on existing software): 514 000 €;
- Reuse of a digital tool to support the work of the EU Platform on Food losses and Food waste: 10 000 €;
- Pilot of a Food processing technologies portal: 240 000 €.

2.2. IT PROJECTS TO SUPPORT THE IMPLEMENTATION OF PLANT HEALTH MEASURES

The actions to be financed under this section target the maintenance and continuous development of the existing EUROPHYT application, the finalisation of a database for harmful organism outbreaks, a plant health import requirements database, the set-up of the register for plant protection products applications, register all plant shipments, and collect data to monitor approved basic material of Community list. These actions are upgrade of existing IT systems and tools.

EUROPHYT is a web-based application for Member States to notify interceptions of consignments that do not comply with plant health requirements. During a meeting with all Member States representatives for Europhyt, a list of required developments was elaborated and prioritised. In addition, on-going support and maintenance will continue.

Based on the recently published legislation on Member States' notification of harmful organism outbreaks (Decision 2014/917/EU), an electronic database will be developed.

The Plant Health import requirements database is under construction and will be finalised before the end of the year.

- The evolutive maintenance of the existing EUROPHYT application: 292 000 €;
- EUROPHYT application support: 88 000 €;
- The hosting of the EUROPHYT application: 70 000 €;
- The development of a database for harmful organism outbreaks: 238 000 €;
- The development of solution to support the sustainable use directive: 200 000 €:
- The development and hosting of a plant health import requirements database: 110 000 €;
- The registering of plant protection products applications: 598 000 €;
- The development of registration of all plant shipments 180 000 €;
- The execution of a data collection to monitor approved basic material of Community list: 60 000 €.

2.3. IT PROJECT SUPPORTING THE FUNCTIONING OF THE COMMON CATALOGUES OF VARIETIES OF AGRICULTURAL PLANTS, VEGETABLES AND VINE, THE COMMON LIST OF VARIETIES OF FRUIT GENERA AND SPECIES AND THE COMMUNITY LIST OF APPROVED BASIC MATERIAL FOR THE PRODUCTION OF FOREST REPRODUCTIVE MATERIAL

The actions to be financed under this section target the maintenance and further development of the existing Common catalogue application and the Common catalogue of varieties of vine. The existing Community list of Approved Basic Material for the Production of Forest Reproductive Material and the Common list of varieties of fruit genera and species will be further developed.

The Common Catalogue application manages the catalogues of varieties of agricultural plants (Directive 2002/53/EC) and vegetables (Directive 2002/55/EC) of which the seeds are not subject to any restriction with regard to their commercialisation within the European Union, as well as in Norway, Iceland and Switzerland

A common catalogue of varieties of vine (Directive 68/193/EEC) shall be maintained.

A common list of varieties of fruit genera and species (Directive 2008/90/EC) shall be established; an existing Community list of approved basic material for the production of forest reproductive material (Directive 1999/105/EC) shall be maintained using a semantic approach.

A database provides for the management of these catalogues by the Commission, for access by the Member States and the electronic data exchange between the Member States, the Commission and the Publication Office.

In 2017, the maintenance of the Common catalogue application and the common catalogue of varieties of vine will be ensured, and the technological functionalities will be updated in order to adapt the system to more up to date developments in electronic publication : $95\ 000\ \epsilon$.

For the Community list of Approved Basic Material for the Production of Forest Reproductive Material, a semantic model has been established to make content accessible and searchable through semantic technology: 260 000 €. The Commission and the Secretariat of the OECD Forest Scheme will prepare a proposal of

collaboration on FOREMATIS towards a single Forest Reproductive Material Information System.

A semantic model is being established to create a Common list of varieties of fruit genera and species and to make content accessible and searchable through this technology: 142 000 €.

The actions to be financed under this budget include the creation and maintenance of IT tools and instruments aimed at ensuring a successful implementation of a series of new requirements applicable to the performance of official controls in the feed law and food law area by the Member States and by the Commission, and/or at fulfilling specific needs or obligations in the field of food and feed controls under the legal basis.

The actions relate to the further improvement and increase of the capacity of databases for the collection of data relating to national control plans and official controls' results, so that the Commission can check their compliance and monitor developments across time, and to the development of online systems for the capturing of data in relation to national control plans and official controls' results, provided by the Member States and/or the Commission.

The actions are:

- The implementation, running, maintenance and, where necessary, continued development of databases in relation to the epidemiologic surveillance of bovine spongiform encephalopathies (Article 6(4) of Regulation (EC) No 999/2001), common authorisation procedure for food additives (Article 10 of Regulation (EC) No 1333/2008), residue monitoring plans (Article 8 of Directive 96/23/EC) and the quantitative results, i.e. reporting of this monitoring: 237 000 €;
- Continued development of an IT system and the maintenance and evolution of dedicated infrastructure that will allow to share, validate and monitor data collected by the Commission in relation to the enforcement of feed and food law in Member States and third countries, including information collected by the Health and Food audits and analysis Directorate. The IT tool should permit the establishment of "Country Profiles", and establishments visited that would facilitate the assessment of control plans submitted by the competent authorities: 322 000 €;
- The implementation and maintenance of a complete and secure system for the management and planning of Union audits according to Regulation (EC) No 882/2004, for the management and storage of audit reports and associated documents and for the follow-up of recommendations resulting from audits, including license costs: 283 000 €;

- 40 000 € for the maintenance and support of the existing Bovine Identification Exchange System.
