The objective of this Implementing Regulation is to amendment model certificates for entry into the Union of certain categories of categories of terrestrial animals and germinal products thereof, i.e. to reflect the reference to the list of third countries authorised for the entry into the Union of consignments of certain animals and products of animal origin intended for human consumption concerning the application of the prohibition on the use of certain antimicrobial medicinal products established by Commission Implementing Regulation (EU) 2024/2598, to reflect new requirements to Chapters E and H of Annex IX to Regulation (EC) 999/2001 of the European Parliament and of the Council introduced by Commission Regulation (EU) 2024/887 as regards caprine animals genetically resistant to classical scrapie strains, to replace the references to the Protocol on Ireland/Northern Ireland by 'Windsor Framework', and to clarify, align and make consistent certain other requirements in the relevant

model certificates for the entry into the Union of consignments of certain terrestrial animals and germinal products thereof.

[PLAN/2024/638], to reflect the reference to the list of third countries authorised for the entry into the Union of consignments of certain animals and products of animal origin intended for human consumption concerning the application of the prohibition on the use of certain antimicrobial medicinal products established by Commission Implementing Regulation (EU) 2024/2598, to replace the references to the Protocol on Ireland/Northern Ireland by 'Windsor Framework', and to clarify and make consistent certain other requirements in the relevant model certificates and model private attestation, for the entry into and transit through the Union of certain categories of animals and goods intended for human consumption.
