





- 31 commercial holdings (516144 different poultry spp) in 10 km zone




Map: geographical location of the HPAI outbreaks, Oct-Dec 2023

HPAI (H5) in Bulgaria 2023, situation from October to November 2023 in poultry

Control measures in place:

- No movement from restriction zones for EU trade;
- Intensified official control in the commercial farms continuing;
- Intensified laboratory control pre-movement testing;
- Enhanced surveillance in wild birds;
- Epidemiological investigation still going on;
- Phylogenetic analyzes of viruses are still in progress;
- > Ban for outdoor keeping of poultry, live poultry market, exhibitions and competitions in the whole country;
- > Enhancing the passive surveillance through awareness campaigns focused on farmers and veterinarians;
- ➤ Meeting with stakeholders local authorities, poultry association, farmers for ensuring early detection, emergency response and preparedness.
