## **SUMMARY REPORT**

A.01 General information by third countries.

A.02 Information point on import-export issues between the EU and UK (GB).

**B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

No item raised.

B.02 Exchange of views and possible opinion of the Committee on a draft Commission amending Implementing Regulation (EU) 2019/1793 on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries implementing Regulations (EU) 2017/625 and (EC) No 178/2002 of the European Parliament and of the Council.

The Commission presented the draft Implementing Regulation amending Regulation (EU) 2019/1793 (7th review) and explained proposed amendments in Annex I, Annex II and Annex IV on temporary increase of official controls and emergency measures for certain food and feed of non-animal origin from certain third countries. Proposed amendments are based on evaluation of the results of official controls during first semester 2022 and proposals received from Member States after detailed discussion in Working Group with Member States' experts. No questions for clarification received from Member States.

Vote taken: Favourable opinion.

B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry, germinal products of poultry and fresh meat of poultry and game birds.

The Commission presented the latest draft amendment of Regulation (EU) 2021/404 which include new templates for the parts 1 of Annexes V and XIV of Regulation (EU) 2021/404, regionalisation of zones newly affected by HPAI outbreaks in Canada, the UK and the US, and reopening of zones in the US where the outbreaks have been cleared for Member States opinion.

Vote taken: Favourable opinion.

B.04 Exchange of views and possible opinion of the Committee on a Corrigendum to Commission Implementing Regulation (EU) 2021/403 of 24 March 2021 laying down rules for the application of Regulations (EU) 2016/429 and (EU) 2017/625 of the European Parliament and of the Council as regards model animal health certificates and model animal health/official certificates, for the entry into the Union and movements between Member States of consignments of certain categories of terrestrial animals and germinal products thereof, official certification regarding such certificates and repealing Decision 2010/470/EU.
