The draft relates to amendments of the model health certificate for meat preparations, the model health certificate for meat products and treated stomachs, bladders and intestines and the model veterinary certificate for fresh meat, excluding minced meat, of domestic solipeds in order to provide the necessary guarantees that the commodities covered by them, when they are produced from, or contain meat of

domestic solipeds, were produced from meat which meets the requirements set out for the imports of fresh meat of domestic solipeds.
