- 1. Technical implementation of the programme
- 1.1 Description and evaluation of the evolution of the epidemiological situation, the technical implementation of the activities foreseen under the programme and the cost-effectiveness of the programme.

In Lithuania no flocks of adult laying hens have been detected positive for salmonella during 2018. No outbreaks of egg born salmonelosis have been reported, however, 794 outbreaks of salmonellosis have been detected in humans in 2018 when the source of the infection have been detected only in one case.

1.2 Details on the level of achievement of the targets set in the approved programme and technical difficulties.

The targets of approved programme have been achieved only partly. All holdings under programme with adult laying hens have been inspected and official samples have been taken with negative results. However, the vaccination of flocks against salmonella have not been carried out. The public procurement procedure have been stopped in the final stage due to formal complains of one participant of the public procurement procedure. Some of the holdings have caried out the vaccination on their own expenses. The procedure have been renewed in 2019.
