SUMMARY REPORT

A.01 General information by third countries.

No item raised.

A.02 Information point on EU-UK readiness and preparedness as from 1 January 2021.

Item was treated in a separate meeting.

B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

No item raised.

B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation laying down the lists of third countries, territories or parts thereof from which the entry into the Union of animals, germinal products, products of animal origin is permitted in accordance with Regulation (EU) 2016/429 of the European Parliament and of the Council.

The Commission presented for the second time to Member States the draft Commission Implementing Regulation laying down the lists of third countries, territories or parts thereof from which the entry into the Union of animals, germinal products and products of animal origin covered by the scope of Commission Delegated Regulation (EU) 2020/692 is permitted, pursuant Article 230(1) of Regulation (EU) 2016/429. The Commission recalled the approach taken to lay down those lists and requested an indicative vote.

B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annex I to Regulation (EC) No 798/2008 as regards the entry for Ukraine in the list of third countries, territories, zones or compartments from which certain poultry commodities may be imported into and transit through the Union in relation to highly pathogenic avian influenza.

The Commission presented a draft Implementing Regulation amending Regulation (EC) No 798/2008 as regards the regionalisation of Ukraine. In particular, the draft

regulation foresees the re-authorisation of imports into the Union of poultry commodities from areas no longer considered infected by HPAI and the suspension of such imports from the area of the country affected by the disease, and which the veterinary authorities of Ukraine have already placed under restrictions.

At the request of a Member States, the Commission provided information on bilateral discussions with Ukraine in relation to the regionalisation of Member States for ASF. No objections were raised by Member States.

C.01 Exchange of views of the Committee on a draft Commission Implementing Regulation (EU) 2019/1793 on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries.

The Draft Commission Implementing Regulation (EU) 2019/1793 on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries has been presented for discussion to the Committee. This draft Implementing Regulation is amending, for the third time, Implementing Regulation (EU) 2019/1793.

The Commission illustrated the changes occurred in this last revision briefly reporting the process and the reasons behind the changes made. There were no comments received after the discussion. The draft will be submitted for vote in January.
