



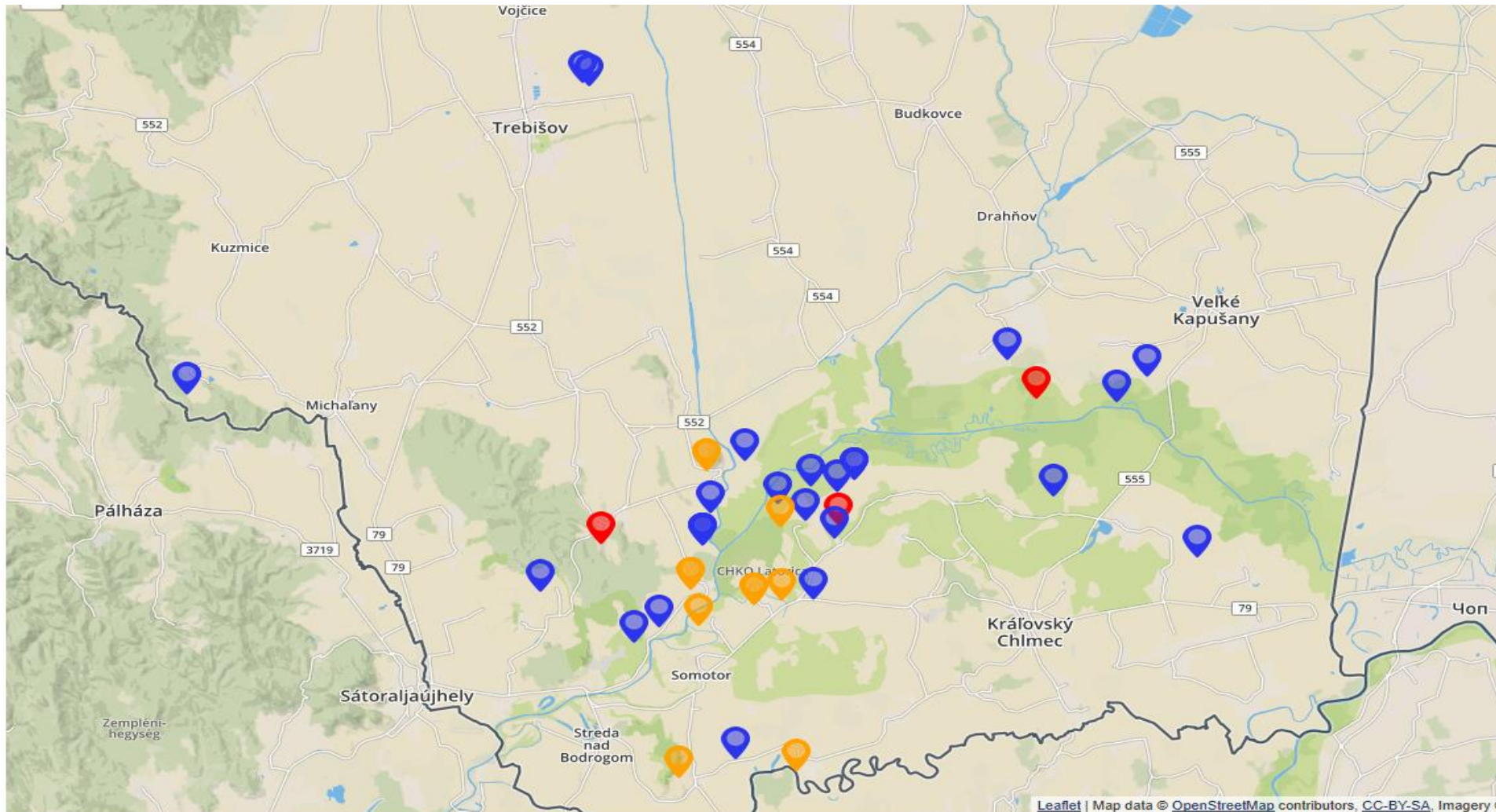

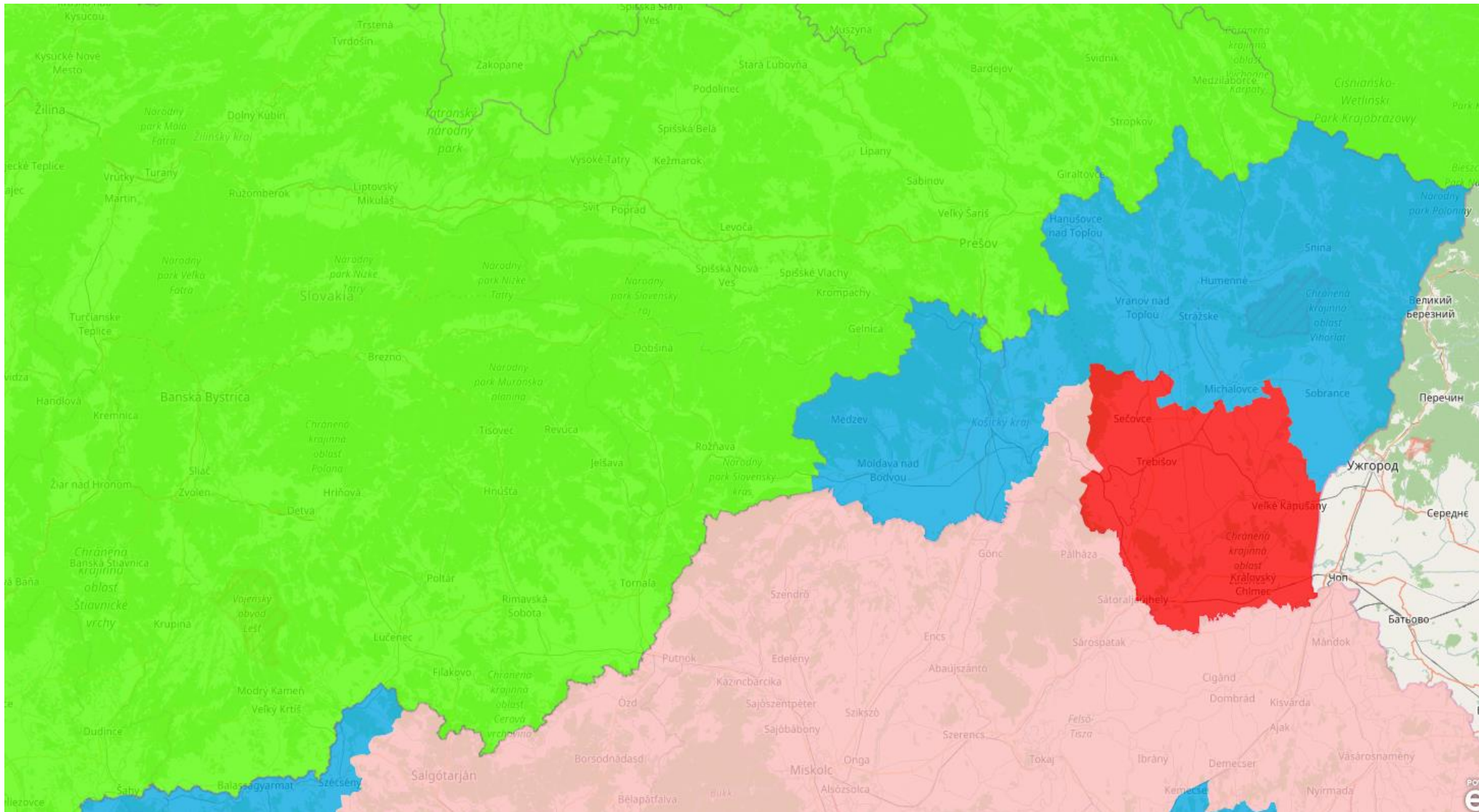
ASF in Slovakia – the development of the situation in the period from October 2019 Paff committee meeting

- Till 23.9. 2019 : 11 outbreaks, 12 positive WB
- From 23.9.2019 till 21.10.2019 : 8 WB confirmed
- From 21.10. till 10.12.2019 : 8 WB confirmed
- No **ASF outbreaks in domestic pigs from 19.8.2019 ahead**
- All domestic pigs outbreaks as well as WB cases confirmed within established part III area (CID 2019/1805/EC)- districts Michalovce/Trebišov (for SK now also part II created) , domestic pigs outbreaks only in district Trebišov (July-August)

Domestic pigs – ongoing activities

- clinical investigation /blood sampling/ of all pigs in protection and surveillance zone - finished on 23.11.2019
- All measures ordered in the surveillance and protection zones in accordance with 2002/60/EC - repealed on 6.12.2019
- Ban of pig breeding in the villages where the virus has been confirmed - ongoing
- reporting obligations of all dead and sick pigs as well as domestic pigs slaughtered to the locals authorities - ongoing
- Slaughtering of pigs originated from part III - in accordance with the relevant legislation 2014/709/EC – designated slaughterhouses
- **FOR THE TIME BEING NO FURTHER REPORTS REGARGING SUSPITIONS/CONFIRMATION OF ASF IN DOMESTIC PIGS**

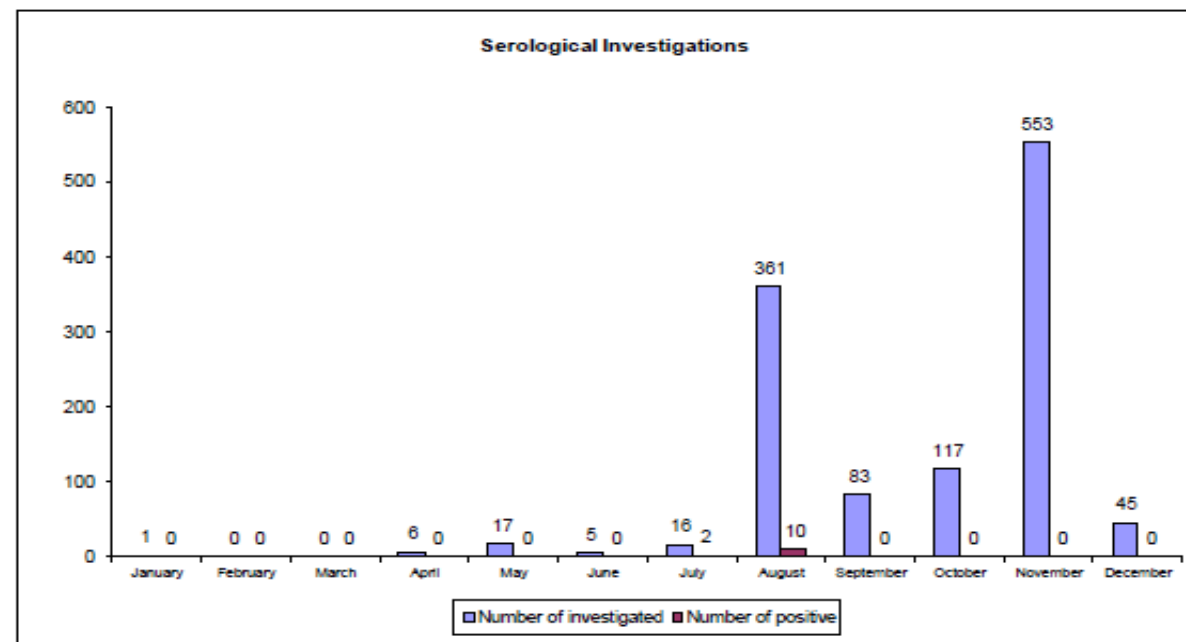
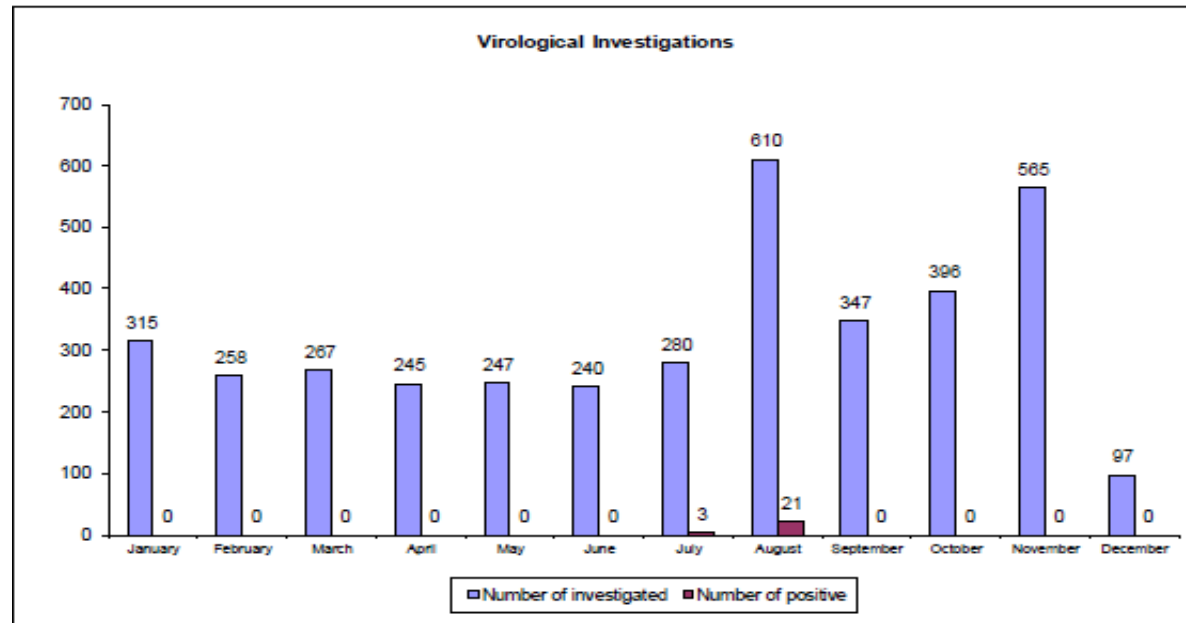

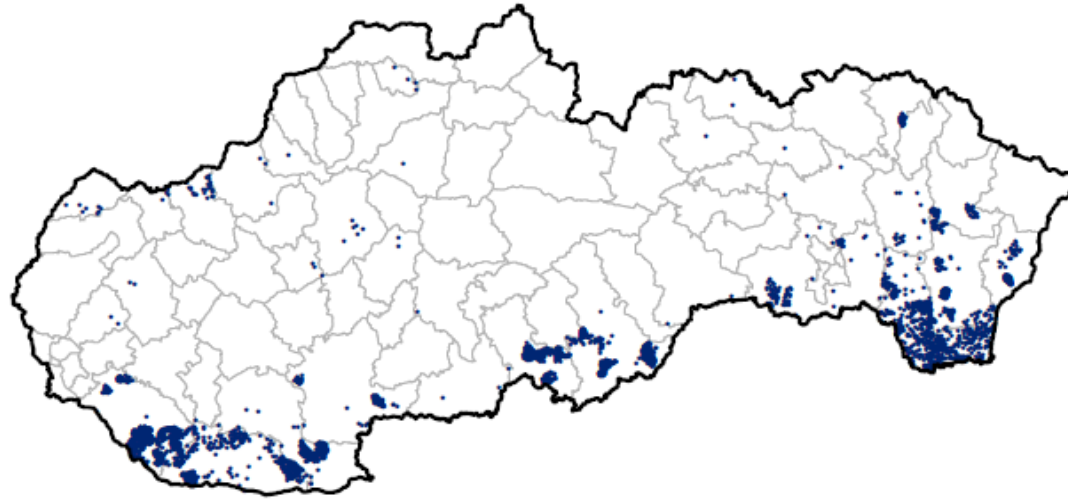

Geographical distribution of samples submitted for ASFV investigation in domestic swine in Slovakia during 2019 (January - 9 December)

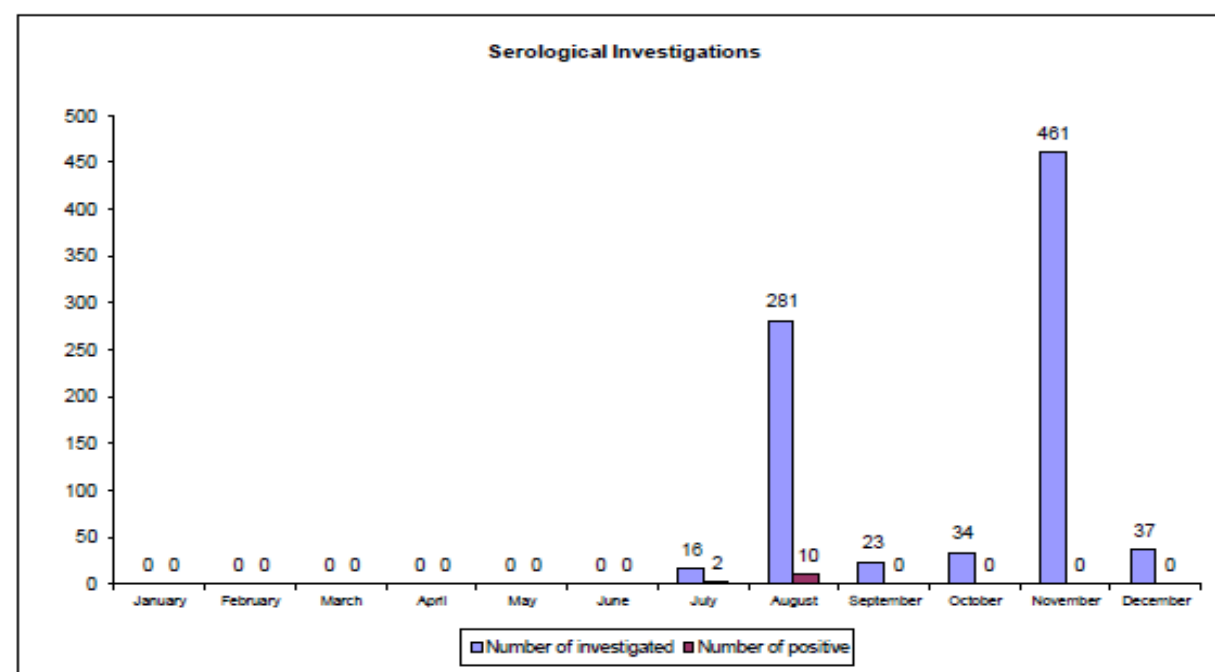
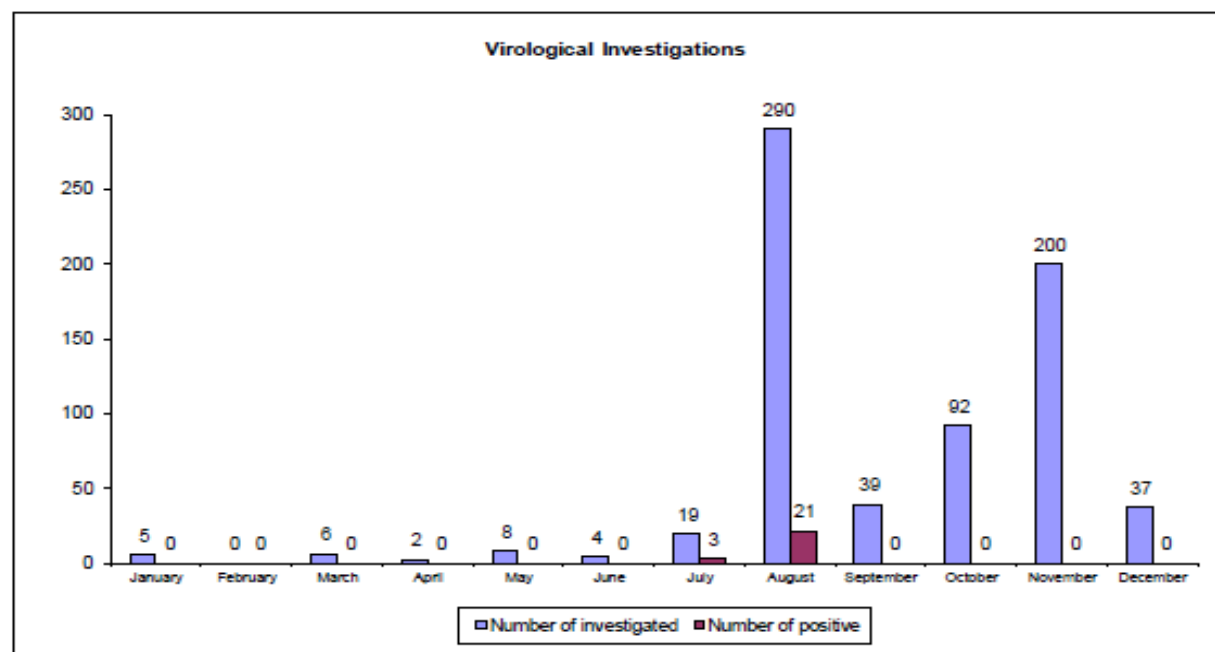

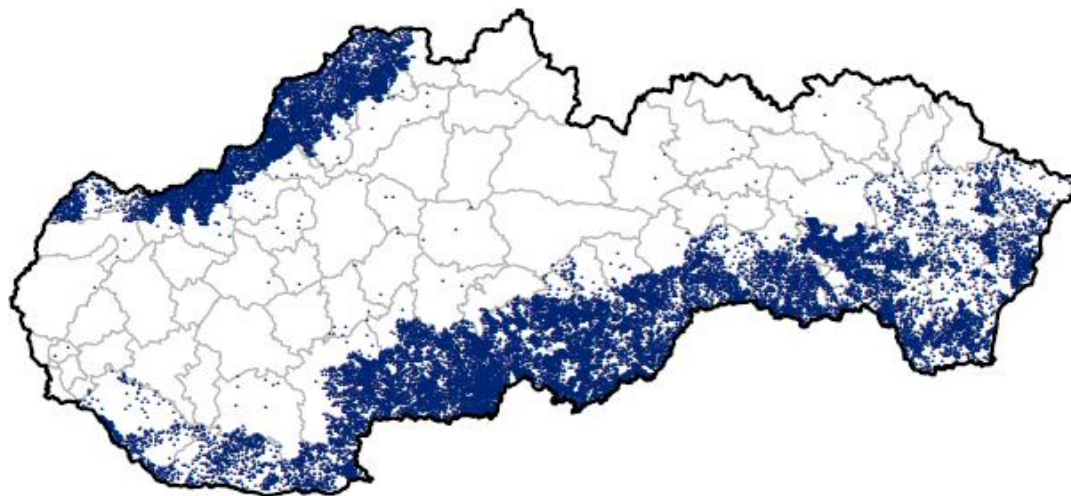
Wild boar management



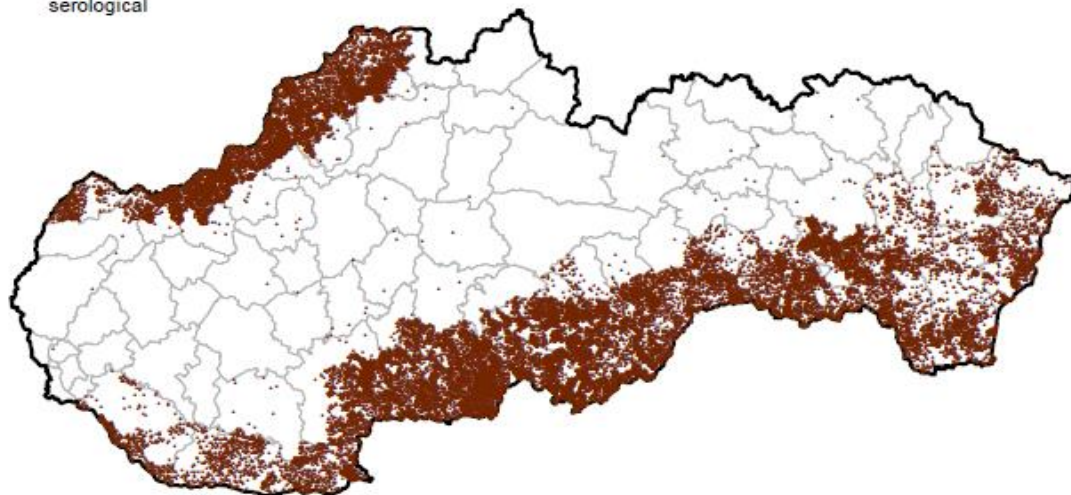
- All measures ordered : mirror the relevant EU legislation and strategical approach the management of ASF
- More precised system of rendering has been established (direct way of cars from infected areas to the rendering plant, removal of WB exclusively in the rendering plant (burial only in exceptional cases)
- Active surveillanc- obligation by WB shot, waiting the results of laboratory investigation
- The distribution of cooling boxes for temporary storage of carcasses until the result are know is continuing (infected areas, buffer zones), up to 600 boxes, next round could be expected in 2020

Geographical distribution of samples submitted for ASFV investigation in wild boars in Slovakia during 2019 (January - 9 December) - active surveillance

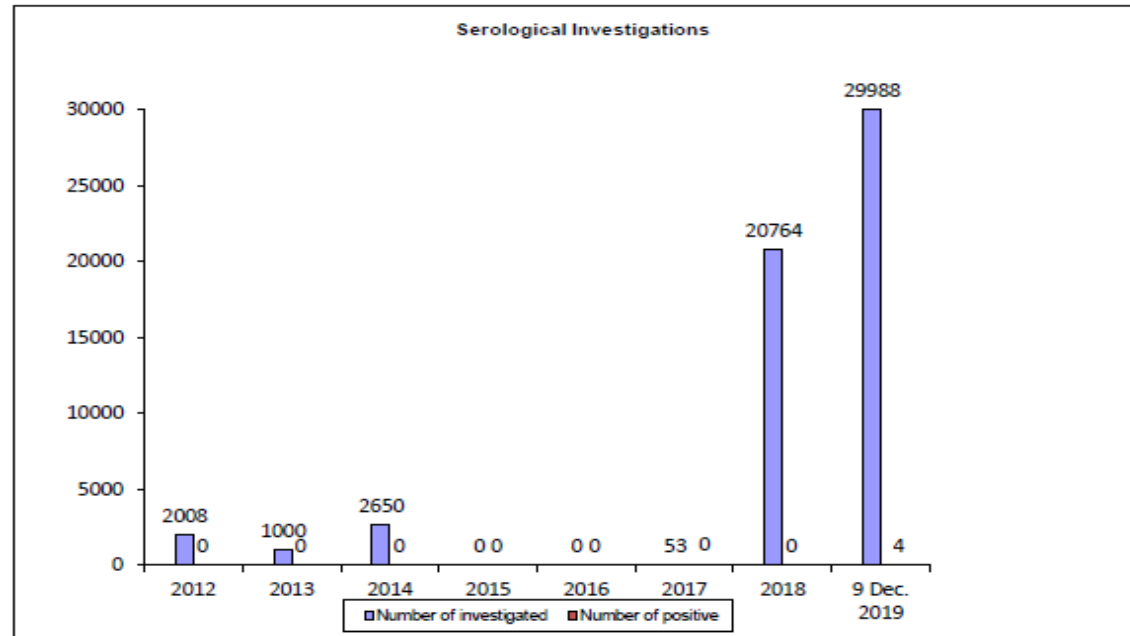
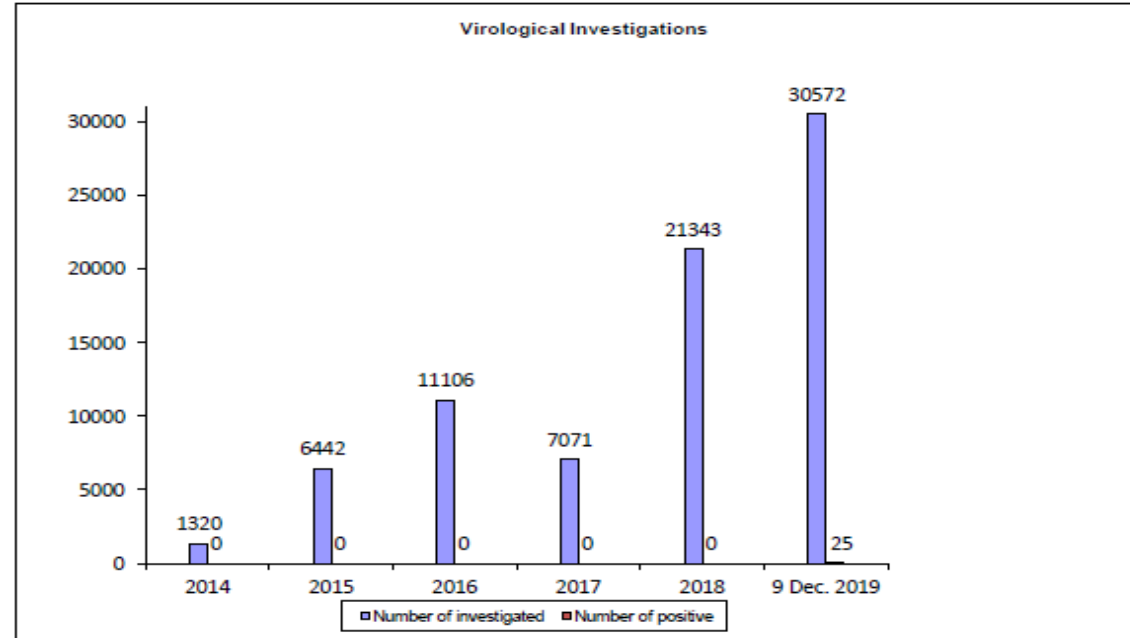

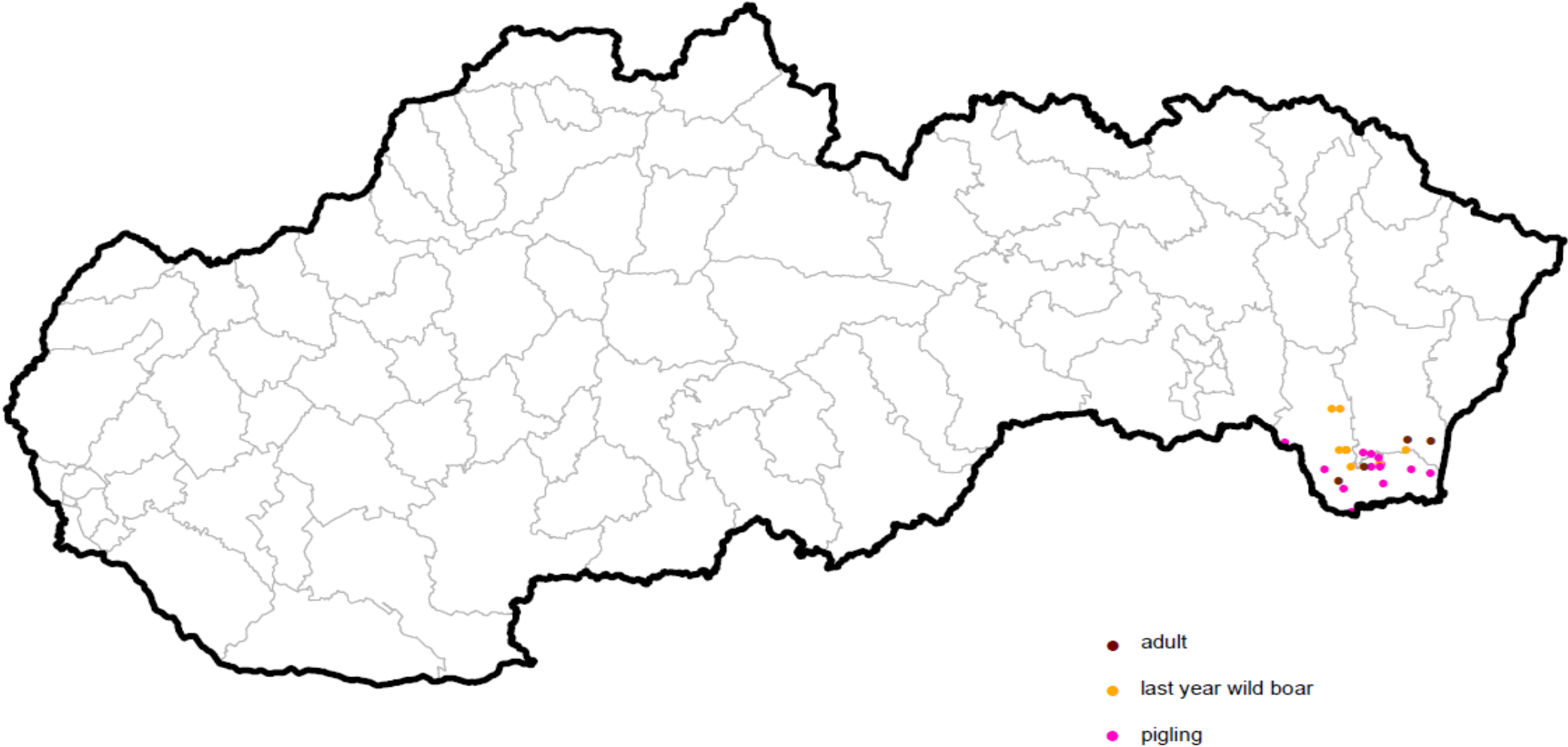

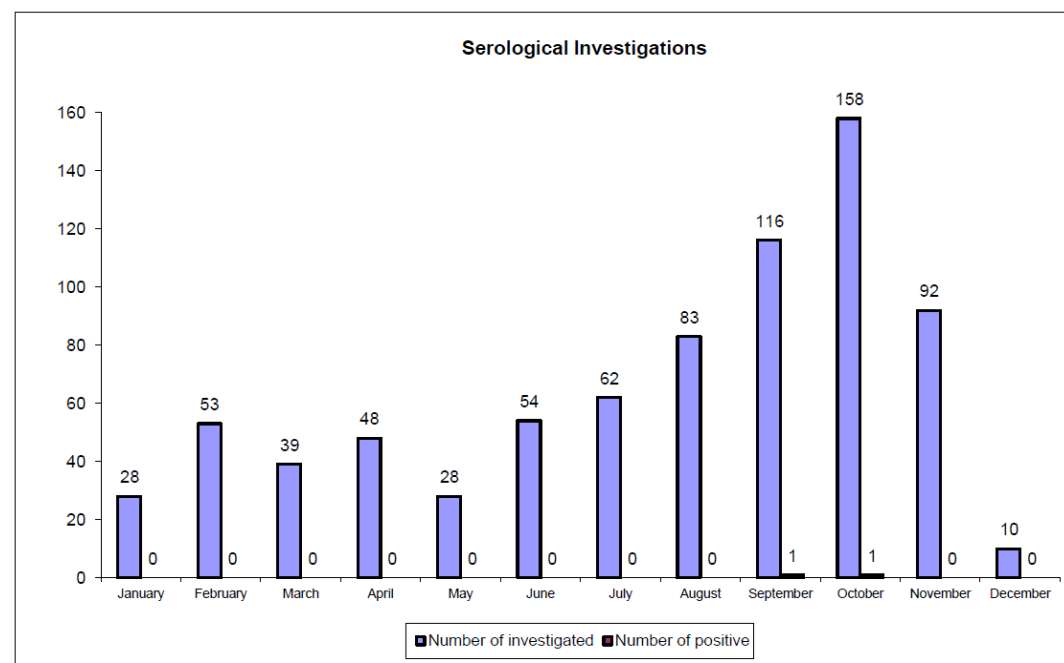

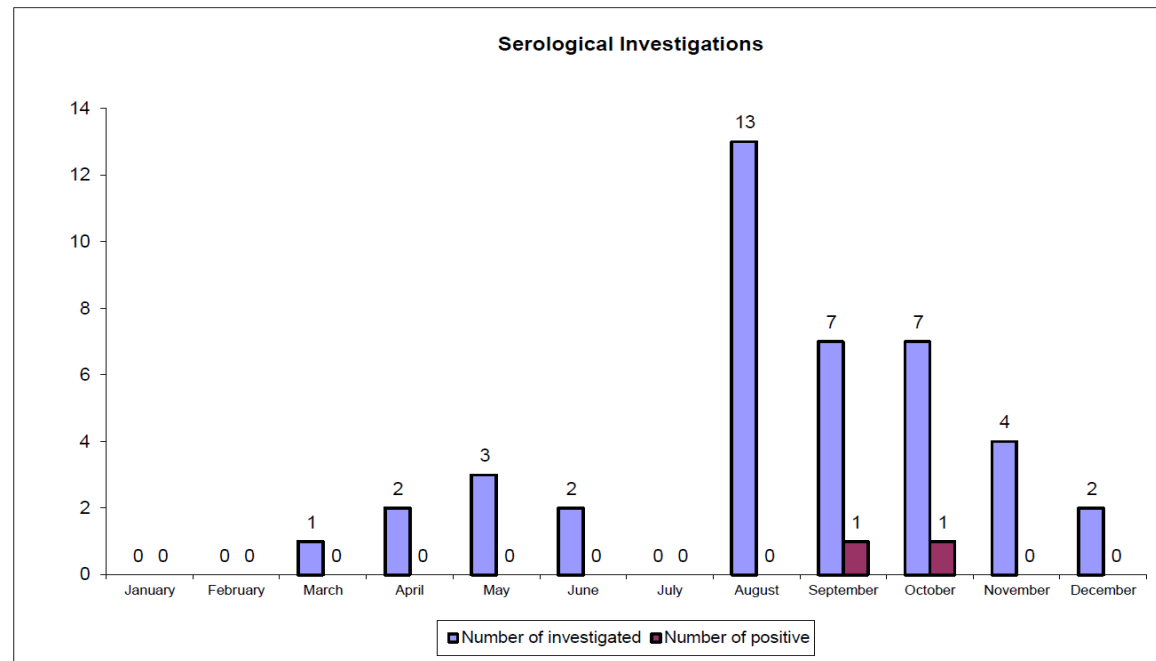
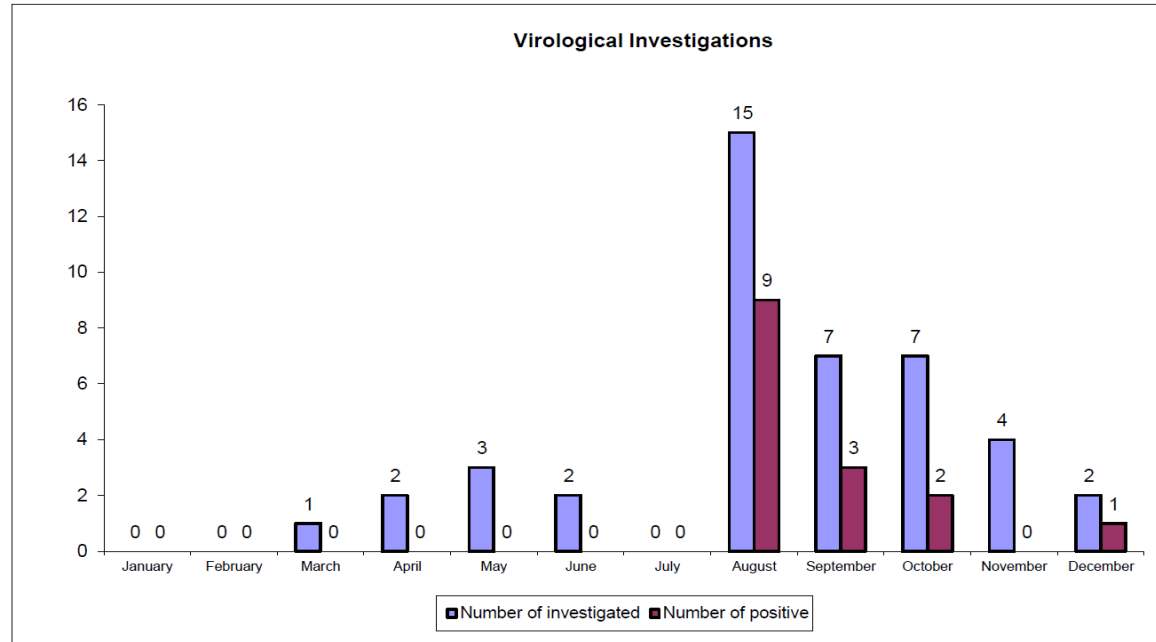
Geographical distribution of wild boars samples positive for ASF virus in Slovakia during 2019 (January - 9 December)

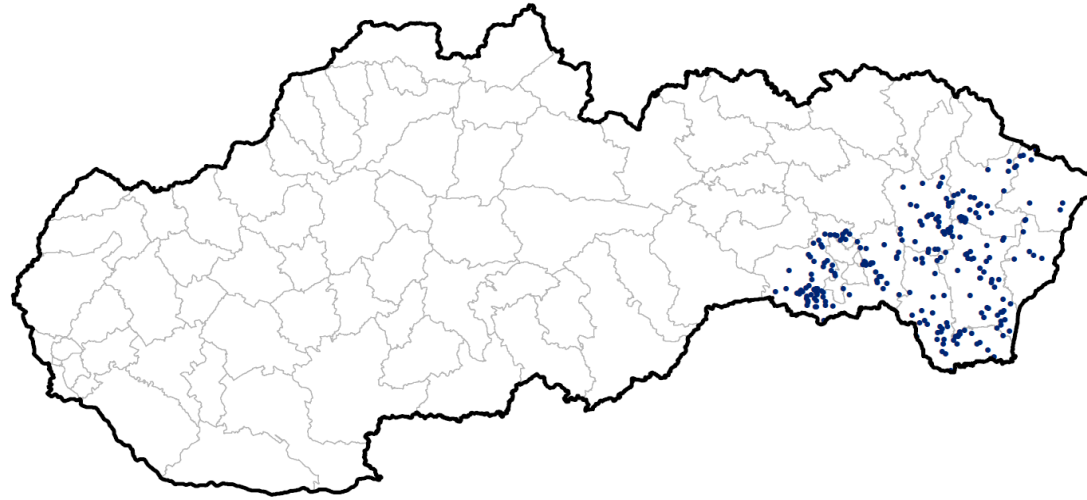


Laboratory Investigations of ASF in wild boars in Slovakia during 2019 (January - 9 December) - passive surveillance - district Trebišov

Increased number of non-commercial pig holdings, (is due to intensive and higher registration already existing farms.

Eradication ASF SK programme

Plan of the eradication of the ASF in the wild boars population has been submitted for review to the EC in November 2019.

Evaluation process is ongoing

- Measures taken in the whole territory (divided in different zones, measures for domestic pigs and WB management)
- Financial provisions
- Laboratory testing
- Organisation and supervision
- Information campaign

Domestic pigs – situation

- Starting of ASF outbreak occurrence 24.7 .2019
- Total outbreaks confirmed: 11, all reported to ADNS/WAHIS
- Last/outstanding (11 outbreak) confirmed on 19.8.2019
- Area of occurrence: all outbreaks within approx. 15-20 km radius only in district Trebišov
- All outbreaks in non - commercial holdings
- Last cleaning and disinfection of outbreaks done: 23.8.2019
- Measures adopted in accordance with 2002/60/EC
- All relevant data/explanation sent to the EC
- Slovakia is requested EC and MS for their positive opinion - for changing /update of infected zones (from part III to part II CD 2014/709/EC)

Next steps/action /challenges I.

- **Prohibition of pig farms (holdings/ non-commercial):** system is under discussion. The steps expected: ordering of domestic slaughter, laboratory investigation of pigs slaughtered for domestic consumption, ban of pig holding, compensations for “lost” pig holdings

Registration of farms

- All villages in part III have sent the list of all pig holdings in the villages (including all non-commercial holdings)
- All holdings which have been identified as “non –registered” have been subsequently registered
- Following the EU-VET team mission a letter dated on 05.09.2019 has been sent to all directors of District Veterinary and Food Administrations in Slovakia regarding importance of registration of pig holdings

Next steps/actions/challenges II.

- **Cooperation with private veterinarians**
- The private veterinarians which perform state veterinary activities (for each year a new contract must be signed) have been trained (the training in relation to contracts for 2020 are ongoing) in order to promote registration process
- Slovak Chief Veterinary Officer participated at the meeting of Slovak chamber private vets and explained them the ASF issue , incl. the role of private vets in the process of early detection of the disease and registration of holdings
- Within clinical checks /examinations of holdings in protection and surveillance zone – from the beginning – they have also identified all non-registered holding which have been subsequently registered.

Next steps/challenges/actins III.

- The census of all pig farms in whole Slovak Republic has been ordered, a letter with that obligation sent to the District Veterinary and Food Administrations. The census should be done to the date 1.1.2020, the report obligation to the central veterinary authority regarding the list of all pig farms will be summarised till 20.1.2020
- Evaluation of controls of biosecurity performed in 2019 in relation to wild boar management – January /February 2020
- Biosecurity controls in non-commercial holdings

Movement of animals

- In whole Slovakia – the sale of pigs to non-registered holders is prohibited
- All movement restriction are in accordance with relevant legislation valid for zone determined
- Each reallocation/movement of pigs in Slovakia is under official supervision – the movement of animals must be accompanied by special document intended for such purpose including the confirmation of performing the clinical checks (health status) before moving
- Cooperation with police – also EU VET team had the possibility to see a lot of police patrols (random places, random timing) on the roads to check whether the animals are transported or not, the source, place of destination...

Conclusions

- 11 outbreaks (backyards) and 26 positive WB confirmed (till 10.12.2019)
- Still localized in the area south/east next to HU border
- Measures in accordance with EC/SK legislation adopted
- The movements restrictions in accordance with 2014/178/EC applied
- Eradication programme - submitted to the EC

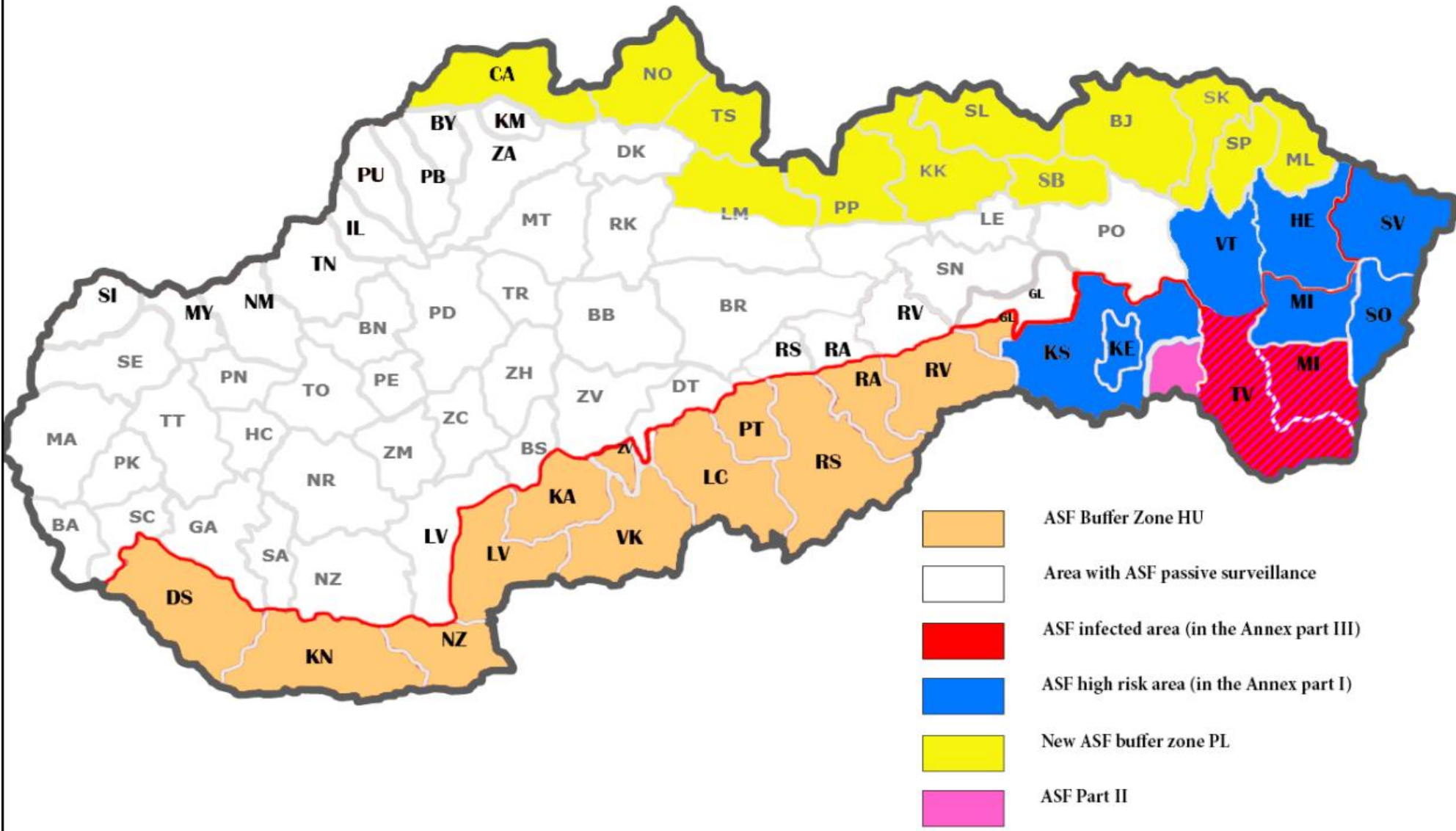

Update of zoning in SK – part II instead of part III.

- taking into account the description of the situation and steps taken and criteria set up in that document, namely
- Non - commercial character of holdings with ASDF occurrence in summer
- More than 3 month period without outbreak
- Clustered occurrence
- Sufficiently large previously area (never detected ASF before)
- Disinfection provided
- Examination as prescribed done (explained in previous slides)
- Slovakia **fulfils these criteria and is asking EC and MS for their support**
- **part III can be diverted into part II** (because of WB positive cases in that area)
