Due to a recent outbreak of OsHV-1 μ Var in Compartment 6 in Poulmarsharry Bay, the geographical demarcation of the disease-free areas is to be updated by deleting the affected compartment.

The aim of this act is to remove the entire territory of Croatia from the list of areas "free with vaccination" regarding Lumpy Skin Disease and the list of countries with an approved Lumpy Skin Disease vaccination programme, given that vaccination against the disease has not been practiced in Croatia since the beginning of 2018 and the results of Lumpy Skin Disease surveillance ever since demonstrated the absence of the disease.
