EMPOWERMENTS ON ENTRY INTO THE EU

DELEGATED ACTS

Article 234 (2): *animal health requirements for the entry into the Union of species and categories of animals, germinal products and products of animal origin from third countries or territories and the movement within the Union and handling of those animals, germinal products and products of animal origin after their entry into the Union, where this is necessary in order to mitigate the risk involved*

EMPOWERMENTS ON ENTRY INTO THE EU

DELEGATED ACTS (I)

Article 237 (4): *derogations from the animal health certificate requirements and specific rules for consignments that pose an insignificant risk to AH or PH within the Union*


Article 239 (2): *derogations and additional requirements for the entry into the Union of certain animals, products of animal origin and germinal products (circuses, events...personal use...etc.)*




APPROACH as regards empowerments

Bundling




APPROACH as regards scope



Requirements for fresh meat







- ***The Commission has to adopt a number of DAs and IAs under the AHL by April 2019, which are interrelated (cross-references), so they must be published at the same time***
- ***One of these DAs will cover the ANIMAL HEALTH requirements for the entry into the Union of animals, PAO and germinal products***
- ***This DA will transpose current legislation on imports under the new legal framework***
- ***Current rules will be updated on content, wording and format to achieve transparency, efficiency, simplification and coherency across different species and different products and to take into account new scientific knowledge***
