**B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

## Procedure: Examination procedure

**B.02** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision laying down the animal health and veterinary certification conditions for the re-entry of registered horses for competition after temporary export to Indonesia, amending Annex I to Decision 93/195/EEC as regards the entry for Indonesia and amending Annex I to Decision 2004/211/EC as regards the entry for Indonesia in the list of third countries and parts thereof from which imports into the Union of live equidae and semen, ova and embryos of the equine species are authorised. (AEF/EC)

The objective of this Decision is to allow for a limited period of time EU registered horses to return to the EU after they have participated in the 18th Asian Games in Jakarta – Palembang, Indonesia, from 18 August to 2 September 2018. This is made possible since the venue in Jakarta will be the core area of an equine disease free zone established to provide the necessary animal health guarantees and to effectively separate EU horses from local equidae. This Decision will set out the specific animal health and certification conditions, allowing re-entry into the Union of registered competition horses.

**B.03** Exchange of views and possible opinion of the Committee on a draft Commission Regulation on the delisting of certain third country establishments from which imports of specified products of animal origin are permitted. (BS)

The draft proposes to delist certain Brazilian establishments from which imports of products of animal origin are currently authorised. The measure is related to the deficiencies recently detected in the Brazilian official control system.
