Transitional measures for animal health/ official certificates

Draft statement for the application of animal health certification in transitional period

Draft statement by the Commission and Member States in the framework of the PAFF Committee for the application of animal health certification during the transitional period between 21 April 2021 and October 2021

- To ensure a smooth transition from the legal framework in force before that date to the new system set up under the Animal Health Law, transitional periods for the use of animal health/official certificates for the intra-Union movements and for entry into the Union have been provided in Commission Implementing Regulations (EU) 2020/2235, (EU) 2020/2236 and (EU) 2021/403
- to ensure a proper adaptation to the change from the current TRACES CLASSIC to TRACES NT

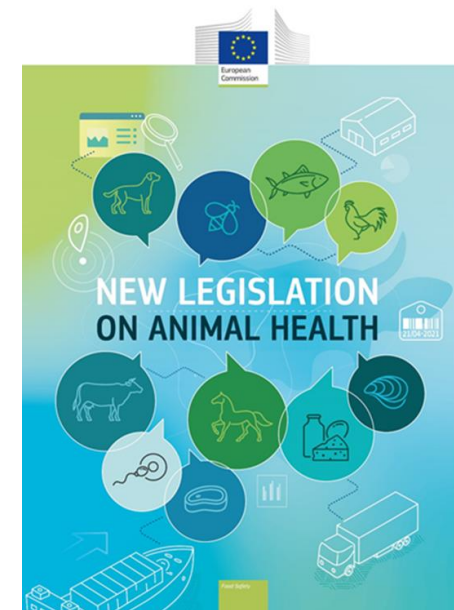
