19.04 - 22.04.2021:


- mortalities: 55 breeding sows without clinical signs;

- first positive test: 19.04;
- confirmation on 20.04.2021

#### Establishment nr. 2 – destination Şiclău – Arad county

19.04 - 22.04.2021:

- first positive test: 19.04;
- confirmation on 21.04.2021;
- possible date of entry of the virus into the holding: 15.04.2021

#### Establishment nr. 1 – origin Gătaia Nouă – Timiș county


- at the time of transport was <u>not</u> included in a restricted zone (protection or surveillance);

- at the time of transport was not included in a restricted zone (protection or surveillance);
- Before movement, was under restriction 19.08.2020-04.03.2021
- at the time of transport, <u>empty</u> since 12.03.2021;
