- B.03** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending the Annexes to Decision 2003/467/EC establishing the official tuberculosis, brucellosis and enzootic-bovine-leukosis-free status of certain Member States and regions of Member States as regards bovine herds. (RS)

The United Kingdom, Italy and Spain have submitted to the Commission documentation demonstrating compliance for the Isle of Man and for several regions with the conditions laid down in Directive 64/432/EEC for officially tuberculosis-free, respectively brucellosis-free status as regards bovine herds. France has submitted to the Commission documentation notifying non-compliance for La Réunion with the requirements for retaining enzootic-bovine-leukosis-free status as provided for in that Directive. The enzootic-bovine-leukosis-free status of La Réunion should therefore be suspended.

The Annexes to Decision 2003/467/EC should therefore be amended accordingly.
