The draft Commission Implementing Regulation that will be presented for discussion and opinion is the twenty-second update of the list of feed and food of non-animal origin (fruits and vegetables, herbs and spices etc.) currently subject to an increased level of official controls at the borders in accordance with the provisions of Regulation (EC) No 669/2009. Article 2 of the Regulation requires the Commission to carry out a review of the list in question at least on a quarterly basis.
