Bluetongue has never been detected in Finland, or in the neighbouring country Estonia. During the years 2007 and 2008 BT has been surveyed in random sample basis. Bluetongue surveillance according to the surveillance plan submitted to the commission on 19th December 2008 was started 1st January 2009.

During the year 2008 the risk for Finland of getting bluetongue changed, while BTV serotype 8 has been detected in the neighbouring country Sweden in September 2008. Sweden also started vaccination campaign against BTV 8 during autumn 2008. A survey of Culicoides species in Finland was performed 2007 (Muldén et al. 2008) and it showed that species capable of being Bluetongue vector exist in Finland.

3. Description of the submitted programme<sup>1</sup>:

3.2. A description and demarcation of the geographical and administrative area, including maps, in which the plan is to be applied.

The vaccination area is going to cover the whole country except the most northern areas Pohjois-Pohjanmaa, Kainuu and Lappi.

Enforced surveillance is applied to the coastal areas in the south and south-west. If bluetongue would spread into Finland by airborne route the first places to be affected would most probably be the coastal areas towards Sweden and probably towards Estonia and Russia.

The rest of Finland, except the most Northern areas Pohjois-Pohjanmaa, Kainuu and Lappi, are taken into the basic surveillance program.

3.3. The likely duration of the plan, and the objective to be attained by the completion date of the plan.

The vaccination plan will be started, if bluetongue cases are detected in Finland, or there are cases close to Finland with immediate danger of BT spreading into Finland. The duration of the plan will be dependent of bluetongue disease evolution in Finland. The minimum duration of the plan will be 3 years.

The surveillance plan was started 1.1.2009 and the surveillance according to this application is direct continuation of the program. The duration of the plan will be dependent of bluetongue disease evolution in Finland and in neighboring countries. In any case the duration of the surveillance plan will be several years.

The measures undertaken to apply a vaccination and surveillance strategy will be based on the measures described in the directive laying down specific provisions for the control and eradication of bluetongue (2000/75/EC) and Commission regulation (EC) 1266/2007 and Commission regulation (EC) No 1108/2008 amending Regulation (EC) No 1266/2007 as regards the minimum requirements for bluetongue monitoring and surveillance programs.

**3.5. Identification and designation of central authority charged with supervising and coordinating the departments responsible for implementing the plan.**

The Finnish Food Safety Authority (Evira) will be in charge of supervising and coordinating the implementation of the plan.

*4.4. Description of the measures of the programme<sup>8</sup>:*

4.4.1. Notification of the disease: ADNS, BT-Net

4.4.2. Target animals and animal population: Cattle, sheep and goats.

4.4.3. Identification of animals and registration of holdings: The animals are ear tagged and registered.

4.4.4. Qualifications of animals and herds<sup>9</sup>: All cattle, sheep and goats in the above mentioned area are taken into the program.

4.4.5. Rules on the movement of animals: Directive 2000/75/EC and Regulation (EC) No 1266/2007.

4.4.6. Tests used and sampling schemes: AB-Elisa for bulk milk and serum samples, PCR to detect the virus. All dairy herds and beef cattle herds at the enforced surveillance area are sampled. In the basic surveillance area 10% of the dairy herds are sampled, chosen by random sampling.

4.4.7. Vaccines used and vaccination schemes: inactivated serotype 8 vaccine. All cattle, sheep and goats vaccinated under official veterinarian supervision. Vaccination used only if bluetongue enters to Finland or it spreads more widely in neighbouring country and the spread into Finland seems imminent. The surveillance plan is carried out in any case.

4.4.8. Information and assessment on bio-security measures (management and infrastructure) in place in the holdings involved: The information is gained through the inspection of the local official veterinarian. Biosecurity guidelines for farms are presented in the national contingency plan for bluetongue. Special attention is taken for hygiene and avoiding wet areas which could promote Culicoides hatching close to the animal premises.

4.4.9. Measures in case of a positive result<sup>10</sup>: In the first BT case stamping out will possibly be used. If the disease appears to be more wide spread the measures are taken according to the Directive 2000/75/EC and Regulation (EC) No 1266/2007. The vaccination campaign will be started if there are BT cases in Finland.

4.4.10. Compensation scheme for owners of slaughtered and killed animals: Where animals are killed and destroyed based on orders of Evira they are fully compensated for their market value as assessed by an independent expert.

4.4.11. Control on the implementation of the programme and reporting: Evira collects the data about the implementation of the programme. The ministry of Agriculture and Forestry approves it and reports to the Commission.

5. Benefits of the programme<sup>11</sup>:

There is a danger that bluetongue would spread into Finland. Estimates about the morbidity and mortality differ, but large financial losses for the producers are to be expected. The aim of the programme is to reduce losses caused by bluetongue to the producers. The surveillance programme makes possible to notice as soon as possible, if bluetongue is spreading into Finland. If bluetongue does not spread to Finland the surveillance programme shows freedom of the disease for safer trade purposes.
