# Context





The Netherlands notified cases of HPAI in wild avifauna on 21<sup>th</sup> october 2020 .  
On 17<sup>th</sup> october 2020, six mute swans were found dead in the province of Utrecht. The analyses of the national reference laboratory confirmed on the 20<sup>th</sup> october an infection with an HPAI H5N8 virus.



# Context




Migratory corridors



The numerous confirmations reported in Germany, the Netherlands, the United Kingdom, Ireland and Denmark, indicate the presence of a strong dynamic of infection by HPAI H5 viruses in wild avifauna in northern Europe and confirm the high risk of introduction of these viruses in holdings.


# First outbreak in France



The 16<sup>th</sup> November 2020, the first outbreak of HPAI of type H5 has been confirmed on French territory. The facility concerned is a garden center with a pet shop, where poultry or other captive birds are kept, in the department of Haute-Corse.

- Date of suspicion of disease on holding : 07/11/2020
- Date of first-line screening: 12/11/2020
- Date of confirmation of disease on holding : 16/11/2020


# First outbreak in France



Immediately the measures required pursuant to Directive 2005/94/EC had been taken in the facility, including:

- All poultry and other captive birds have been killed under official supervision (15/11/2020);
- Number of susceptible animals on holding (poultry) : 575
- Number of animals affected on holding (poultry) : 116
- Number of animals that have died of the disease on holding (poultry) : 111
- Number of animals killed and destroyed or rendered on holding (poultry) : 464

# First outbreak in France



Immediately the measures had been taken in the facility, including:

- Disinfection cleaning operations have been executed (16-17/11/2020);
- All objects and waste likely to be contaminated that can't be disinfected has been destroyed (16-17/11/2020);
- Epidemiological investigation is ongoing. All identified French holdings links are placed under surveillance: precautionary measures, clinical vigilance and taking samples from species still present, and disinfection cleaning operations on empty buildings and areas.
  - Links with other MS (BE, NL, CZ) are under investigation

Protection and surveillance zones are under definition.


# Protection and surveillance zones

- Including an important broiler site 6 km away




40 breeding holdings  
2 slaughterhouses




Surveillance zone

# National HPAI risk level



Decree of November 17, 2020  
High level risk of IAHP in the  
entire metropolitan area



Implications: confinement of poultry,  
a ban on fairs, wildfowl releases and  
waterfowl hunting with "calling" birds.  
Certain exemptions are permitted.
