# 5. Discussion and possible approval by the Sub Committee of a report on the inactivation of viruses in blood

### Rapporteur: Prof. Van Oirschot

Prof. Van Oirschot explained the request for opinion at the origin of the paper. The present draft was an initial working document and needed thorough discussion. Main points of discussion were the validation of methods aimed at inactivating virus infectivity in blood while maintaining the serum properties. Comments sent by Dr. Ahl and Prof. Alexandersen were also included in the discussion.
