





- ✓ **Implementing acts will be developed 2019-2020**
 - Drafting ongoing
 - Working groups ongoing / planned in 2019 and 2020
- ✓ **Outstanding and other non-key delegated acts to be developed**
 1. *Vaccination (Art 47 of AHL) - 2020*
 2. *Union antigen, vaccine and diagnostic reagent banks (Art 48(3) of AHL) - 2020*
- ✓ **Training, presentation, supporting documents**
 - BTSF and other: starting 2020, and will continue 2021 onwards
