B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

(Emergency disease)

Procedure: Examination procedure

B.02 Exchange of views and possible technical agreement of the Committee on a draft Commission Implementing Regulation establishing the list of animals and goods, including their codes from the Common Nomenclature, to be subjected to official controls at border control posts. (CJ)

Technical vote on the draft Regulation establishing the list of animals, products of animal origin, germinal products, animal by-products and derived products, hay and straw subject to official controls at the EU border in accordance with Article 47 of the Official Controls Regulation. The draft Regulation does not cover composite products as for those, Commission Decision 2007/275/EC will continue to apply until 21 April 2021.

B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Annex II to Decision 2007/777/EC as regards the entries for Bosnia and Herzegovina and Russia in the list of third countries or parts thereof from which the introduction into the Union of meat products and treated stomachs, bladders and intestines is authorised. (EV)

B.04 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation (EU) to lay down detailed rules on minimum requirements for border control posts, including inspection centres, and for the format, categories and abbreviations to use for listing border control posts and control points. B.05 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annexes I and II to Regulation (EU) No 206/2010 as regards the models of veterinary certificates BOV-X, OVI-X, OVI-Y and RUM and the lists of third countries, territories or parts thereof from which the introduction into the Union of certain ungulates and of fresh meat is authorised. (CMB)

The foreseen amendment to Regulation (EU) No 206/2010 concerns:

- amending the entry for Canada to recognise the country as being seasonally free of epizootic haemorrhagic disease between 1 November and 15 May and amend the relevant models of veterinary certificates consequently.
- updating the regionalisation of Argentina in Annex II to authorise certain zones for the introduction of fresh meat of certain ungulates reflecting the current animal health situation of those zones.
- updating the UN provisional reference for the former Yugoslav Republic of Macedonia for the Republic of North Macedonia to reflect the outcome of the bilateral agreement reached in June 2018 between Athens and Skopje.
