
Commission working document No SANTE/7112/2015/Rev 3 on principles and criteria for geographically defining ASF regionalisation states that:


- in case of total depopulation of all non-commercial farms with low biosecurity conditions, the period without any outbreaks can be reduced to 3 months or,
- in case of outbreak (in an area with no ASF outbreaks in domestic pigs for the past 12 months) - 3 months after the disinfection of infected holding (in accordance with Article 10.4 (a) of Directive 2002/60/EC) and provided that measures referred in Article 10.4 (b) (clinical and laboratory examinations) or in Article 10.5 (intensive sampling and testing programme) of Directive 2002/60/EC are implemented





#### Biosecurity measures (1)

- General biosafety measures are listed in Animal Health Law (article 10).
- In addition to that there is also a list of compulsory biosafety rules that are applied in case that there is ASF situation in the country (The Regulation of Minister of Rural Affairs No 27 from 19.05.2022, § 2):
  - keep animals in the building in the way that they do not have access to outside
  - keep animals so that they do not have contact with other kept animals;
  - vehicle transporting ABP can not enter fenced area of the farm;
  - keep animals in the building in the way that they do not have access to outside
  - keep animals so that they do not have contact with other kept animals;
  - vehicle transporting ABP can not enter fenced area of the farm;
  - no inventory, feed and bedding exchange with other farms/holdings;

#### Biosecurity measures (2)

- no contact to any part of feral pig (hunted or dead wild boar/meat/byproducts) at the farm territory;
- forage or any other substance that can be contaminated, can not enter the farm;
- feed must be stored at least 30 days before usage and kept away from animals or any other substances/things that can carry virus or that feed is heat-treated outside farm;
- bedding must be stored at least 90 days before usage and kept away from animals or any other substances/things that can carry virus;
- farm area is fenced. Fence has to be in contact with the ground so that no animal can enter far, building and its territory, including storage locations of inventory, bedding, feed, water, manure and slurry;
- no swill feeding

#### Biosecurity measures (3)

- Biosecurity measures listed in Annex II of Regulation 2023/594 are also applied.
- In the areas under restrictions home slaughtering must be notified to local veterinary centre who will organise the supervision and if necessary sampling.
- Animal keeper draws up biosafety plan for the abovementioned measures and records implementing it.
- The general requirements for hygiene measures in the primary production are specified in annex of Regulation (EC) No 852/2004 of 29 April 2004 on the hygiene of foodstuffs.
