The proposed Implementing Regulation amends Chapter 29 (model EU-FISH) of Annex III to Implementing Regulation (EU) 2020/2235 by restoring erroneously deleted Part II of that Chapter by Commission Implementing Regulation (EU) 2023/2744 and updating references to new legislation regarding residues and public health requirements for the entry into the Union of products of animal origin and goods for human consumption; and corrects Chapter 28 (model FISH-CRUST-HC) by deleting certain erroneously inserted, by Implementing Regulation (EU) 2023/2744, footnotes from its point II.2.6.2 (i) and (ii).
