ASF in Slovakia – state of play – year 2023

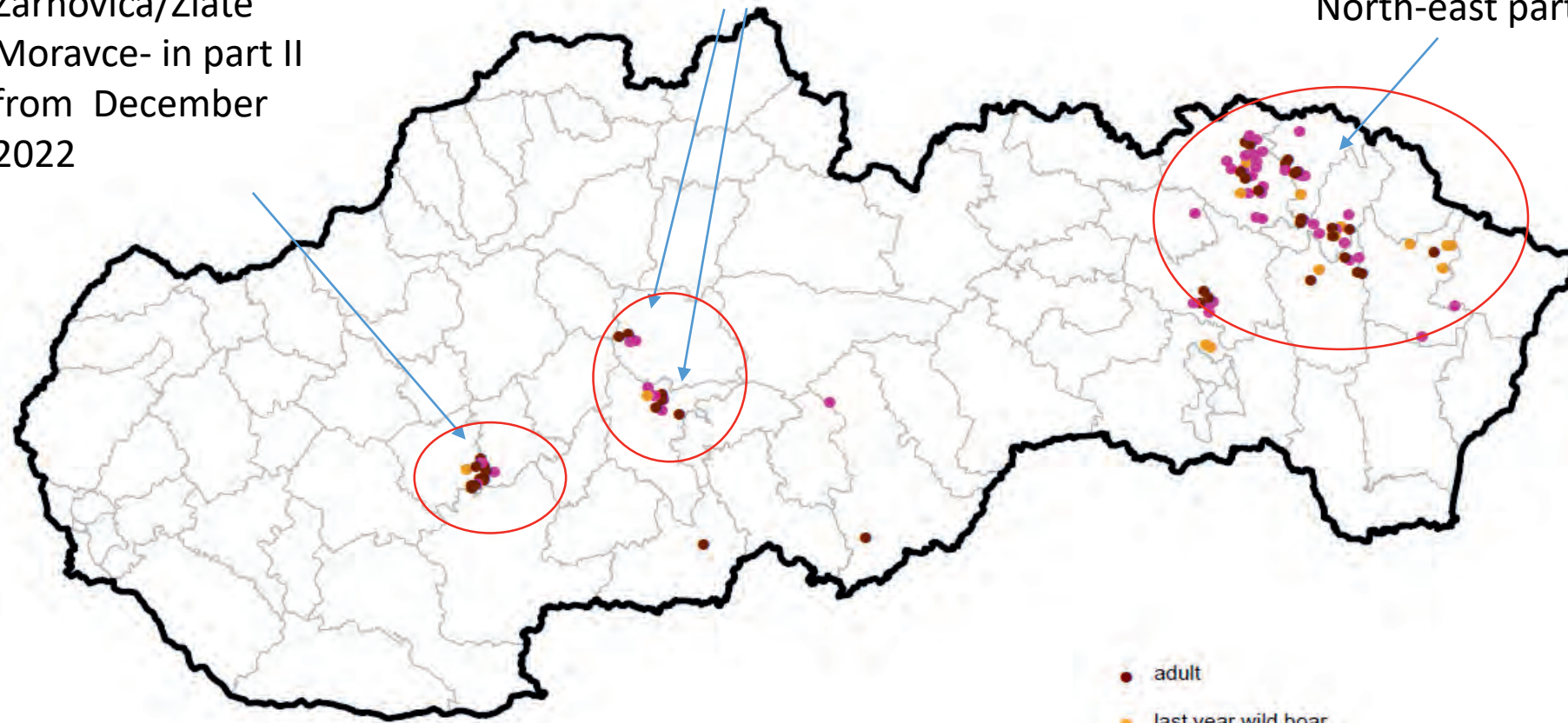
- year 2023: **113** ADIS reports (up to 13.02.2023)
- From the last PAFF committee: up to 60 new ADIS messages in WB ; 0 in domestic pigs
- **All WBs confirmed within existing part II zone**
- The most positive results : northeast part of Slovakia (longer period of time in zone II); one region in the central part of Slovakia (longer period of time in part II) and in region Zarnovica and Zlate Moravce (new infected region –added into part II in December 2023)
- One change of zones envisaged/proposed for this Paff Committee

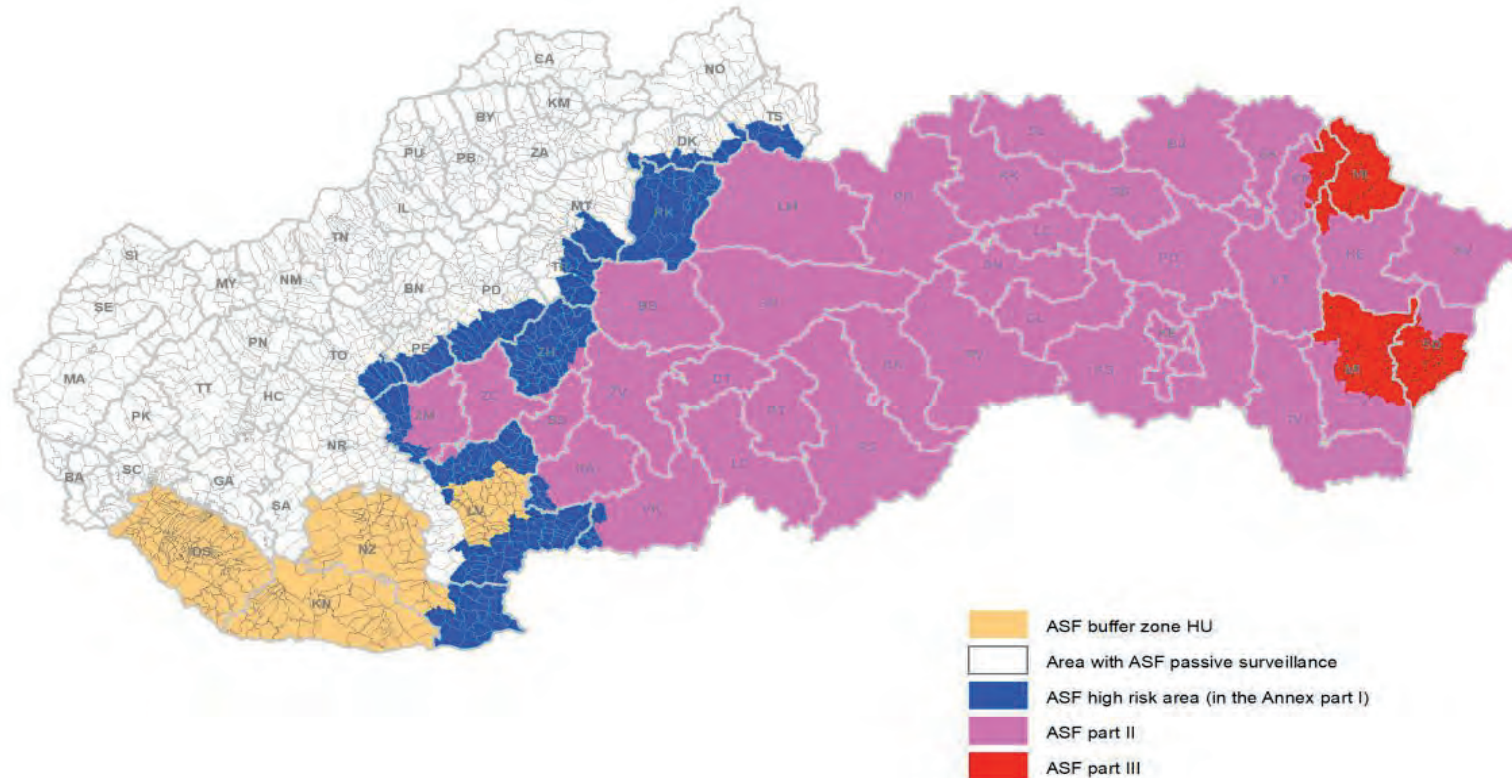

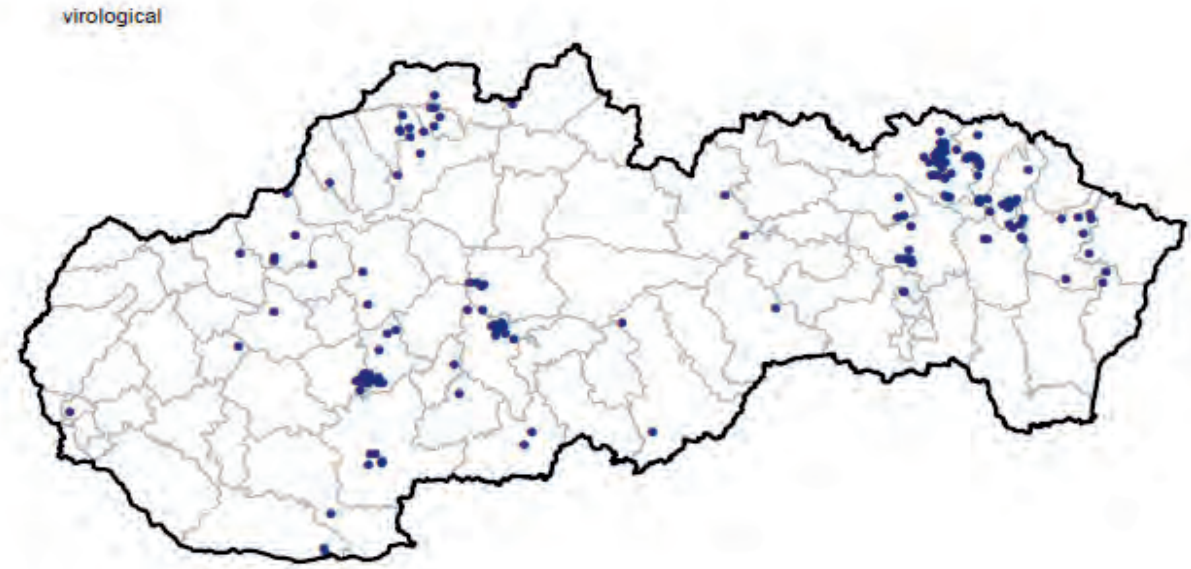

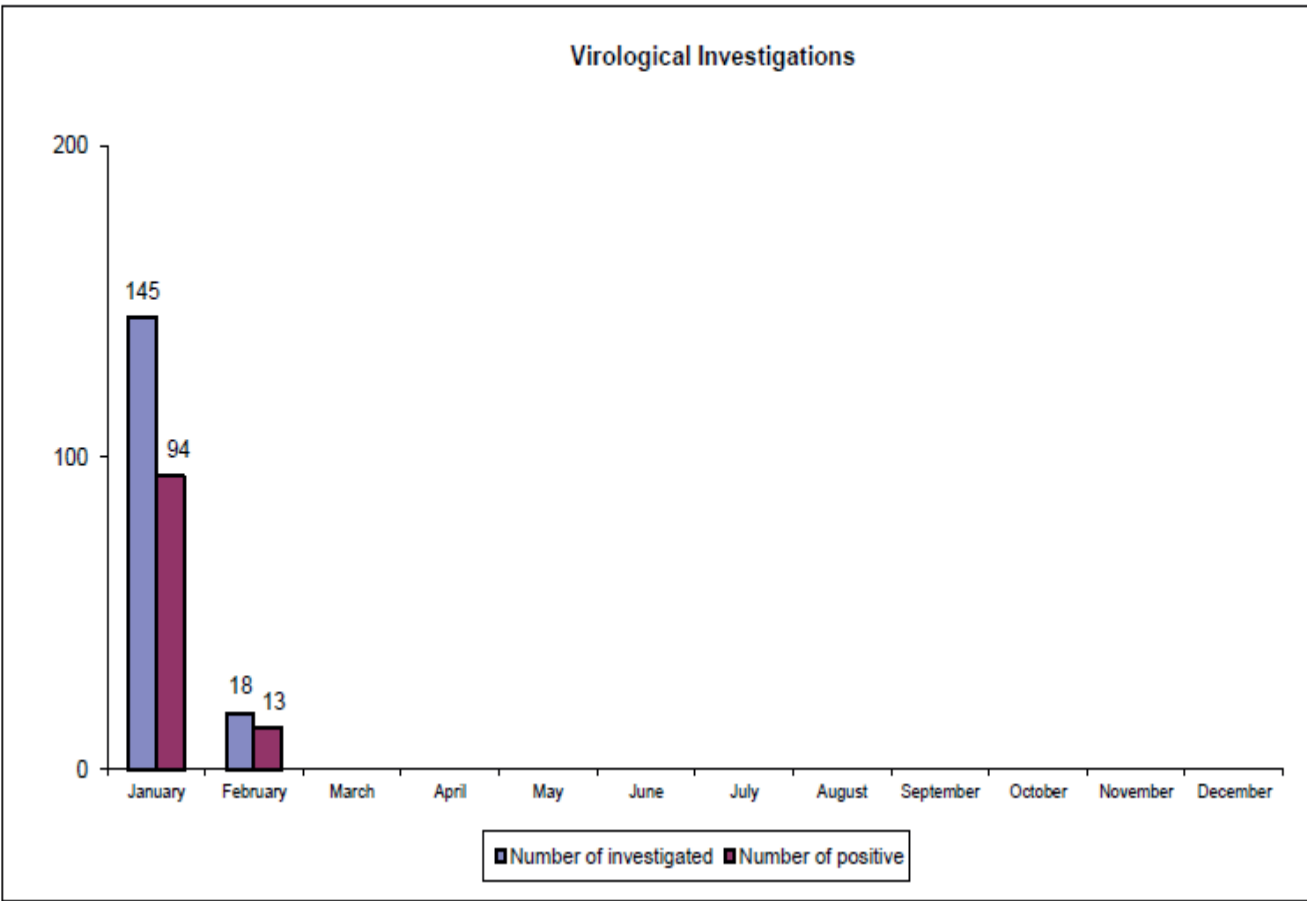

Geographical distribution of samples submitted for ASFV investigation in wild boars in Slovakia during 2023 (January - 8 February) - passive surveillance

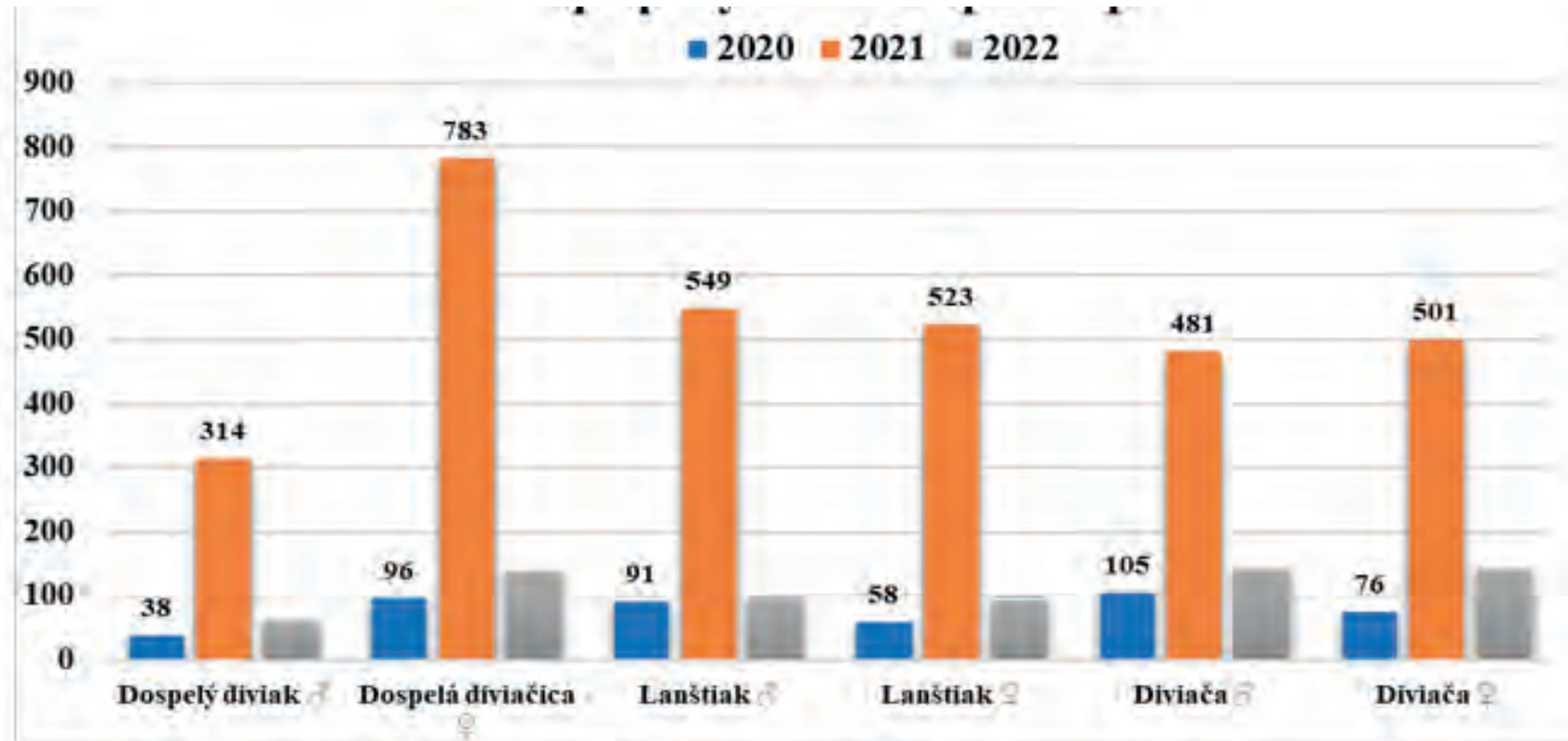

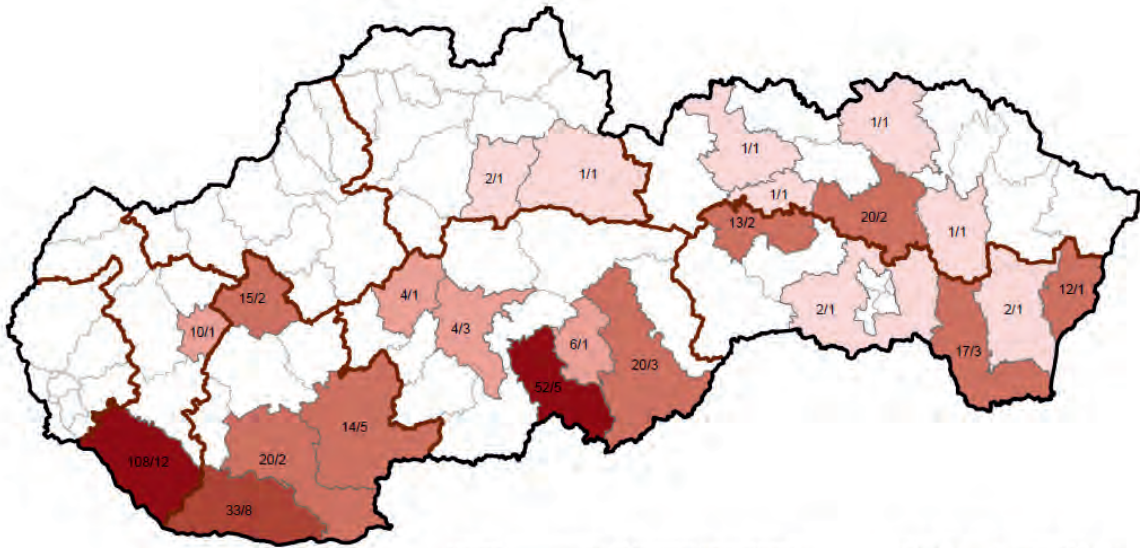


Positive WB- layout by category 2020-2022

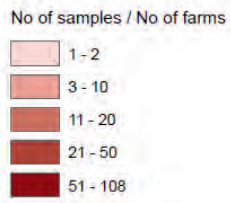
dospely divak- adult WB, dospela diviaca- adult female; lanstiak- last year WB, ; diviaca- pigling



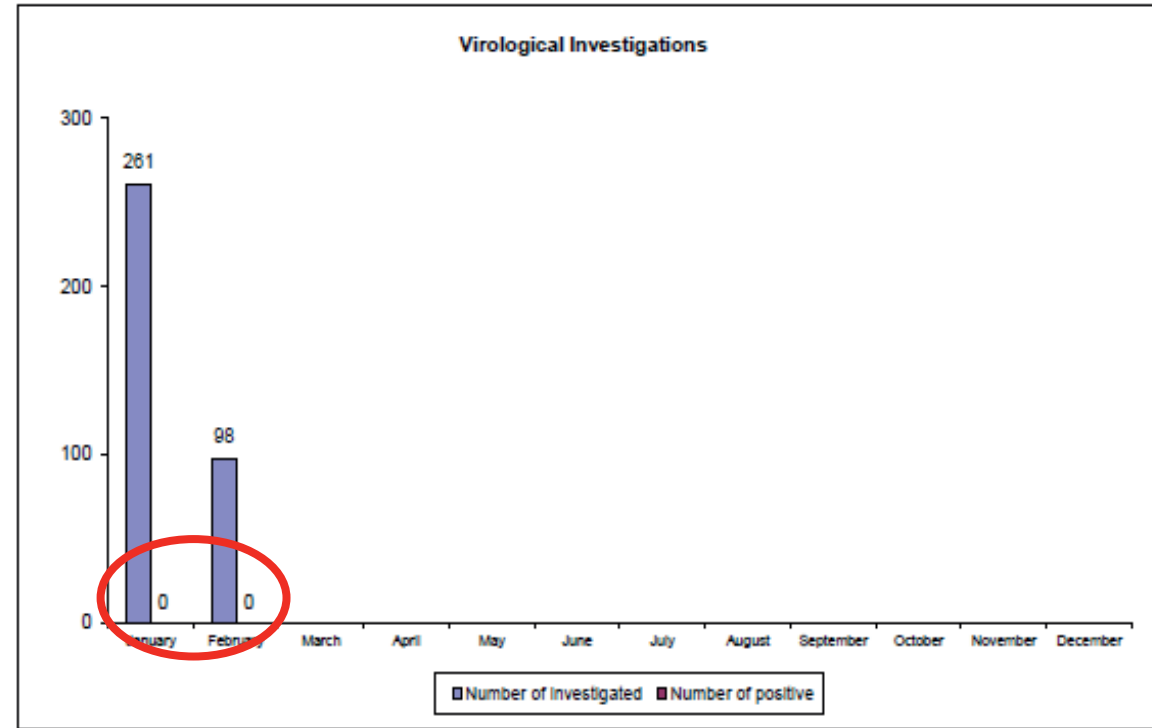
Geographical distribution of swine samples investigated for ASF virus in Slovakia during 2023 (January - 8 February)



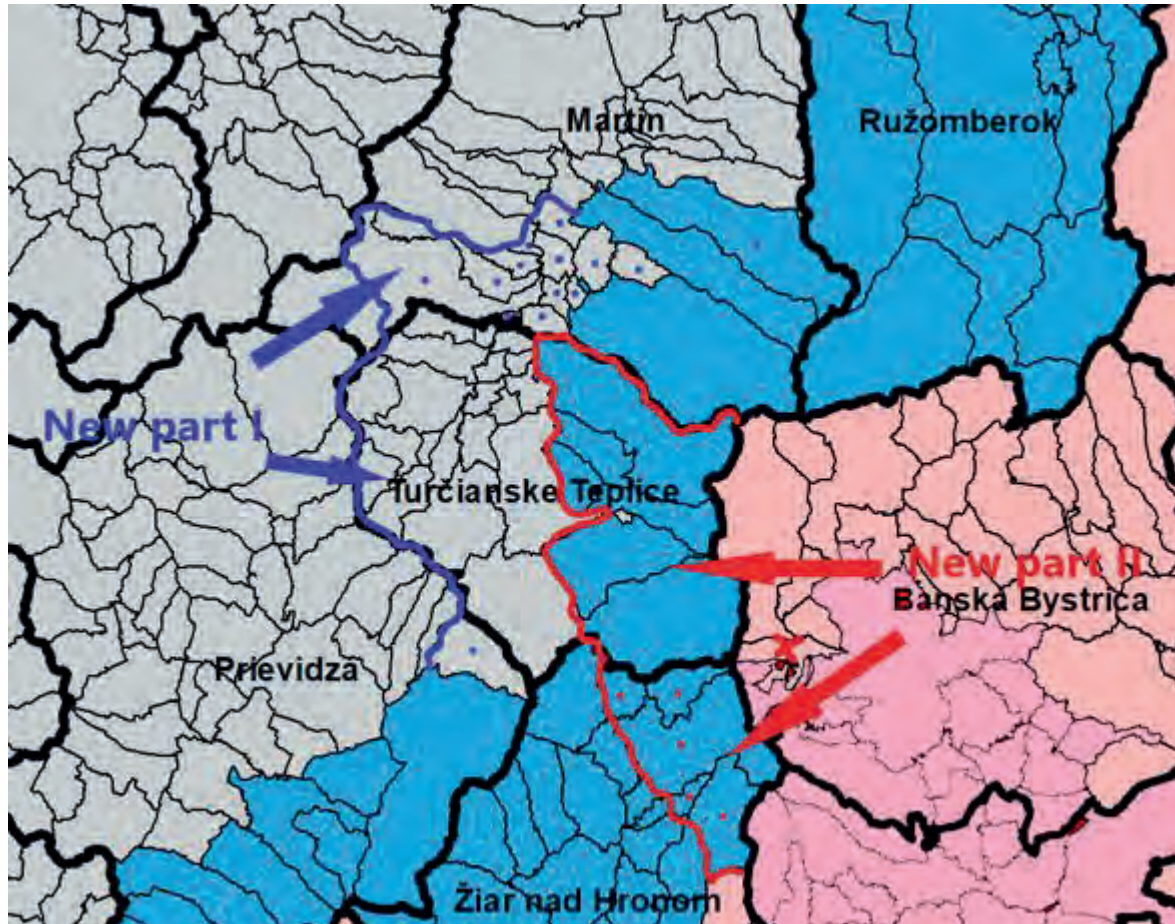

with part I



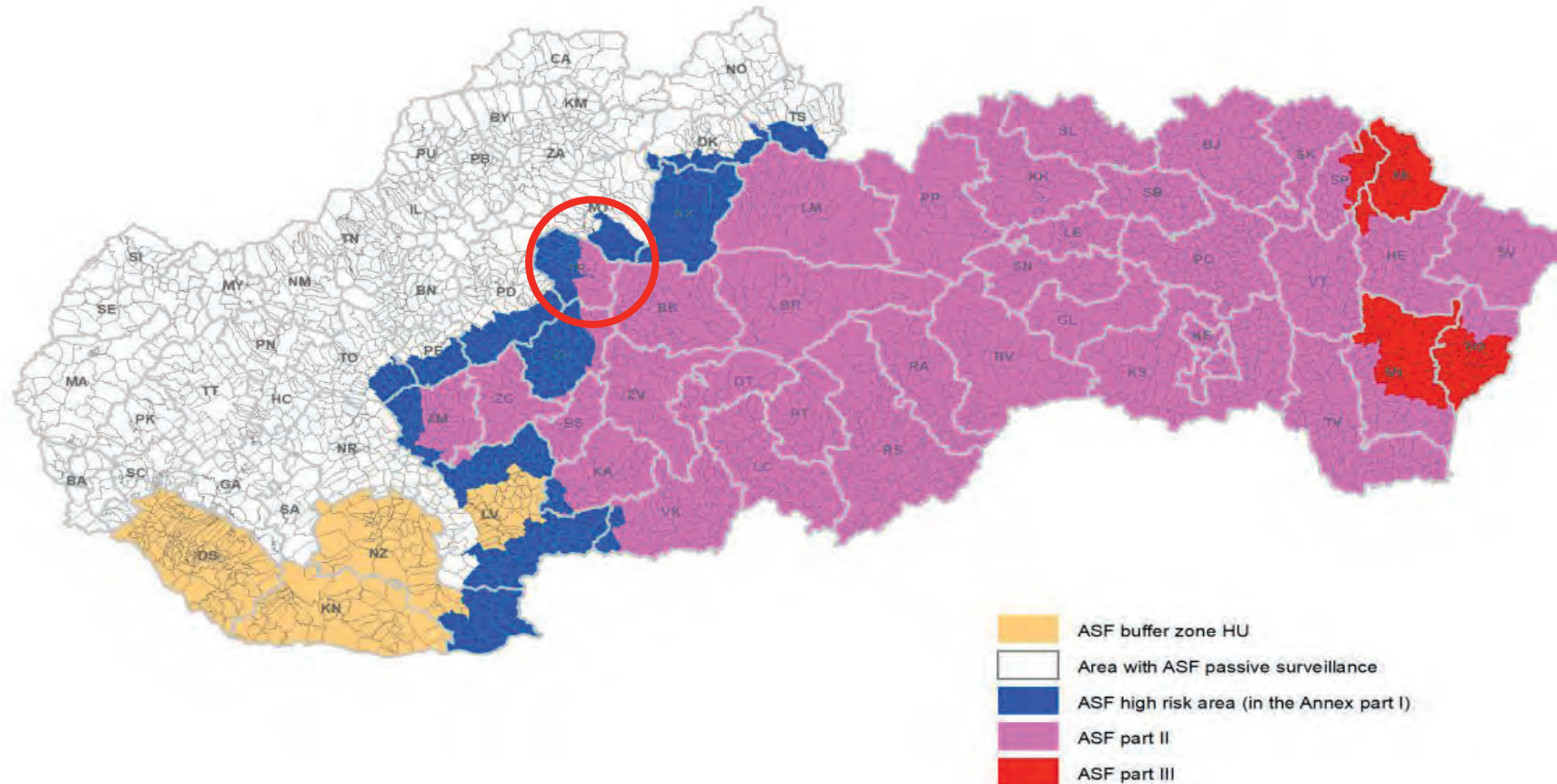

Summary – ASF in Slovakia

- An update of the eradication plan ASF for 2023 done at national level, EC will be informed in due course with the key elements (changes) of the programme
- Co-financing request for ASF programme expected to be in place in Slovakia in 2023 successfully arranged by having support from HADEA experts (grand agreement for 2023)
- Right now: One enlargement of part II proposed – central part of Slovakia
- If the situation remains calm, SK will ask the EC and the MS for their support for removing outstandings 2 small regions (Michalovce, Medzilaborce) from part III and to revert them into part II in March 2023 via Paff committee
