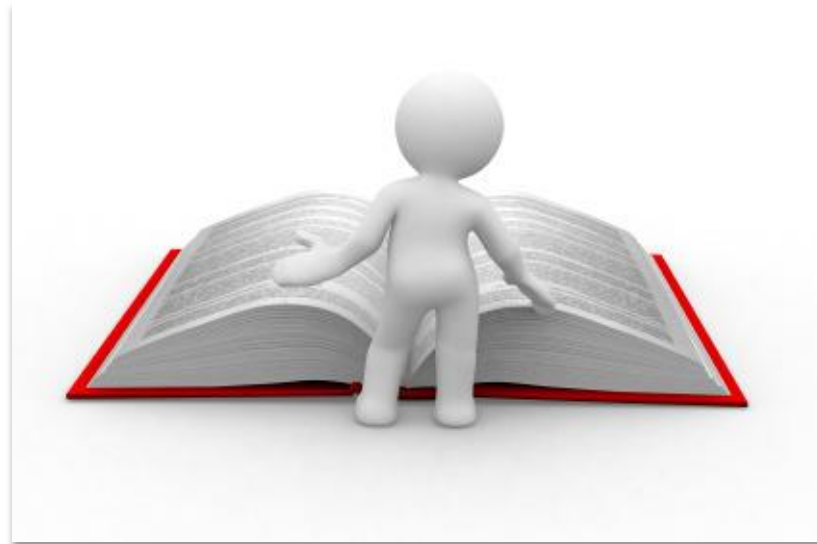

CURRENT LEGISLATION ON INTRA-UNION TRADE IN ANIMALS

Current approach

Basic act

- **Directives**
 - Requirements for trade in different species (bovine/ porcine, ovine/caprine, equine, poultry/hatching eggs, all others
 - General requirements

Implementing acts

- **Implementing Decisions for different commodities**
 - Usually amending Annexes to basic acts, including Models of certificates

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (I)

Article 131 (1)

- (a) residency periods*
- (b) the period of time necessary in order to limit the introduction of kept ungulates or poultry into establishments prior to movement*
- (c) supplementary requirements to ensure that kept ungulates and poultry do not pose a significant risk*
- (d) other necessary risk-mitigation measures*

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (II)

Article 135

- (a) specific rules for assembly operations,*
- (b) criteria for assembly operations on means of transport,*
- (c) the timeframe between the time of departure of the kept ungulates or poultry from their establishment of origin and their departure from the assembly operation*
- (d) detailed rules as regards the biosecurity measures for assembly operations*

Article 139 (4)

rules for derogations [in respect of assembly operations] by the competent authority of the place of destination

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (III)

Article 140

(a) specific requirements for

- (i) circuses, zoos, pet shops, animal shelters and wholesalers;
- (ii) exhibitions and sporting, cultural and similar events;

(b) derogations from Sections 2 to 5

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (IV)

Article 144 (1)

- (a) derogations from the animal health certification*
- (b) special rules for animal health certification as provided for in Article 143(1) where specific risk-mitigation measures concerning surveillance or biosecurity are taken,*
- (c) the requirement for animal health certification for movements of species and categories of kept terrestrial animals other than those referred to in points (a), (b) and (c) of Article 143(1)*

Article 146

- (a) content of animal health certificates*
- (b) additional information to be contained in the animal health certificate*

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (V)

Article 149 (4)

- (a) the types of documentary, identity and physical checks and examinations*
- (b) the timeframes for the carrying-out of such documentary, identity and physical checks and examinations and the issuing of animal health certificates by the official veterinarian prior to the movement of consignments of kept terrestrial animals;*
- (c) the duration of the validity of animal health certificates.*

Article 151 (3)

- (a) detailed rules on the content of the self-declaration document*
- (b) information to be contained in the self-declaration document in addition to that provided for in paragraph 2 of this Article.*

EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

DELEGATED ACTS (VI)

Article 154 (1)

- (a) *the requirement for advance notification by operators*
- (b) *the information needed in order to notify movements of kept terrestrial animals as provided for in Articles 152 and 153*
- (c) *the emergency procedures for the notification of movements of kept terrestrial animals in the event of power cuts and other disturbances of Traces*
- (d) *the requirements for the designation of regions by Member States for the management of notifications of movements, as provided for in Article 153(3).*

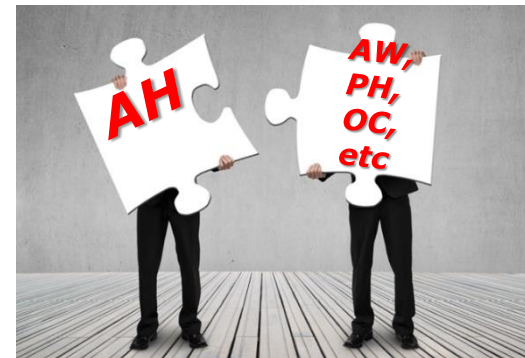
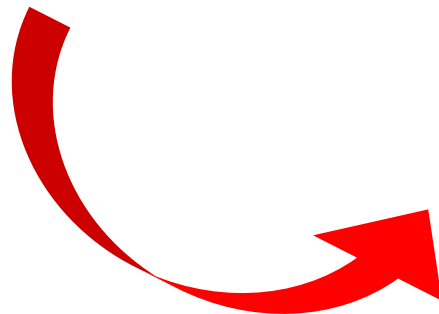
EMPOWERMENTS ON MOVEMENTS WITHIN THE UNION

IMPLEMENTING ACTS

Article 141(1): *temporary rules for movements of specific species or categories of kept terrestrial animals*

Article 146(2): *rules for model forms of animal health certificates*

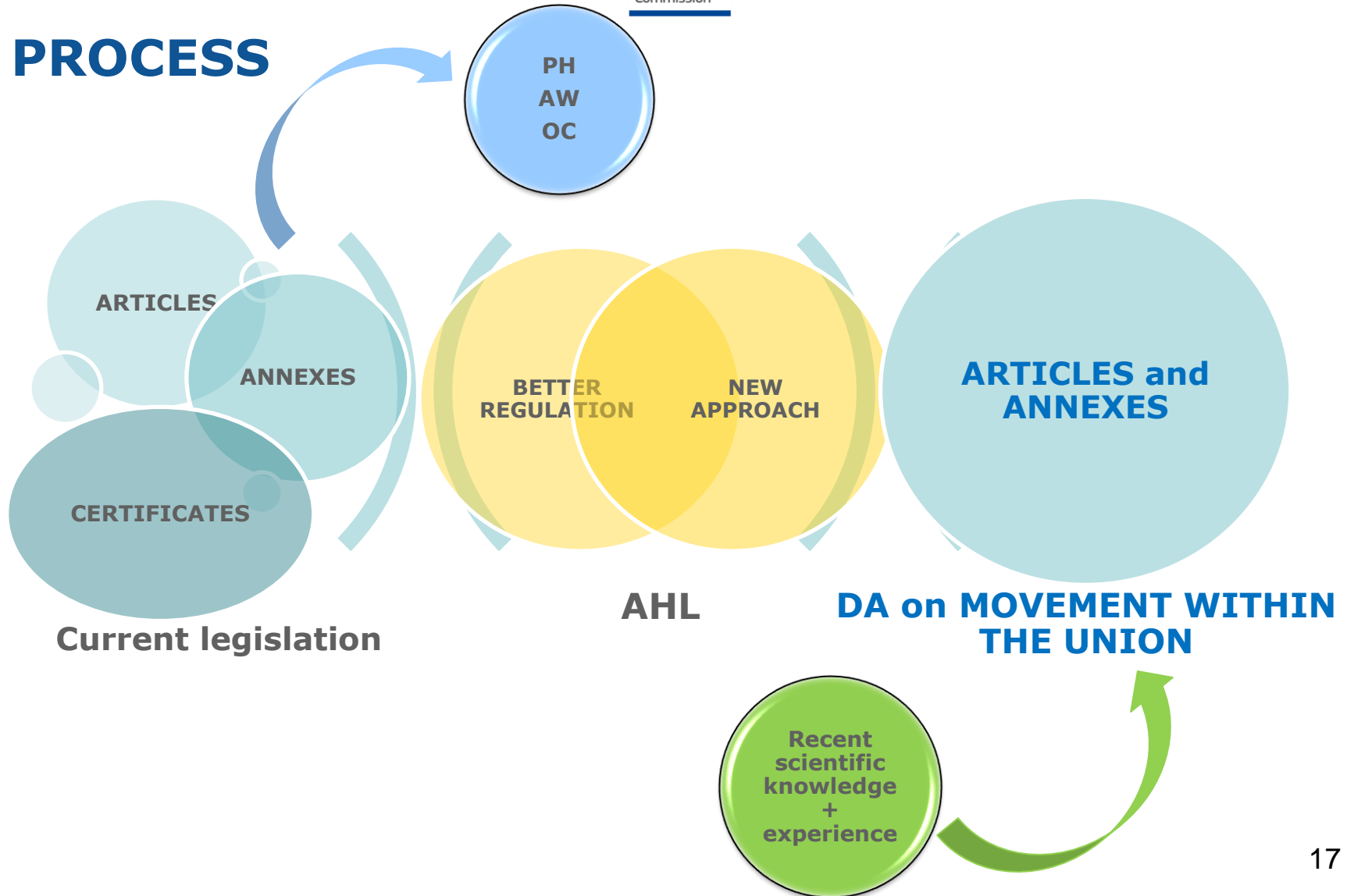
Article 151(4): *rules for model forms of self-declarations*



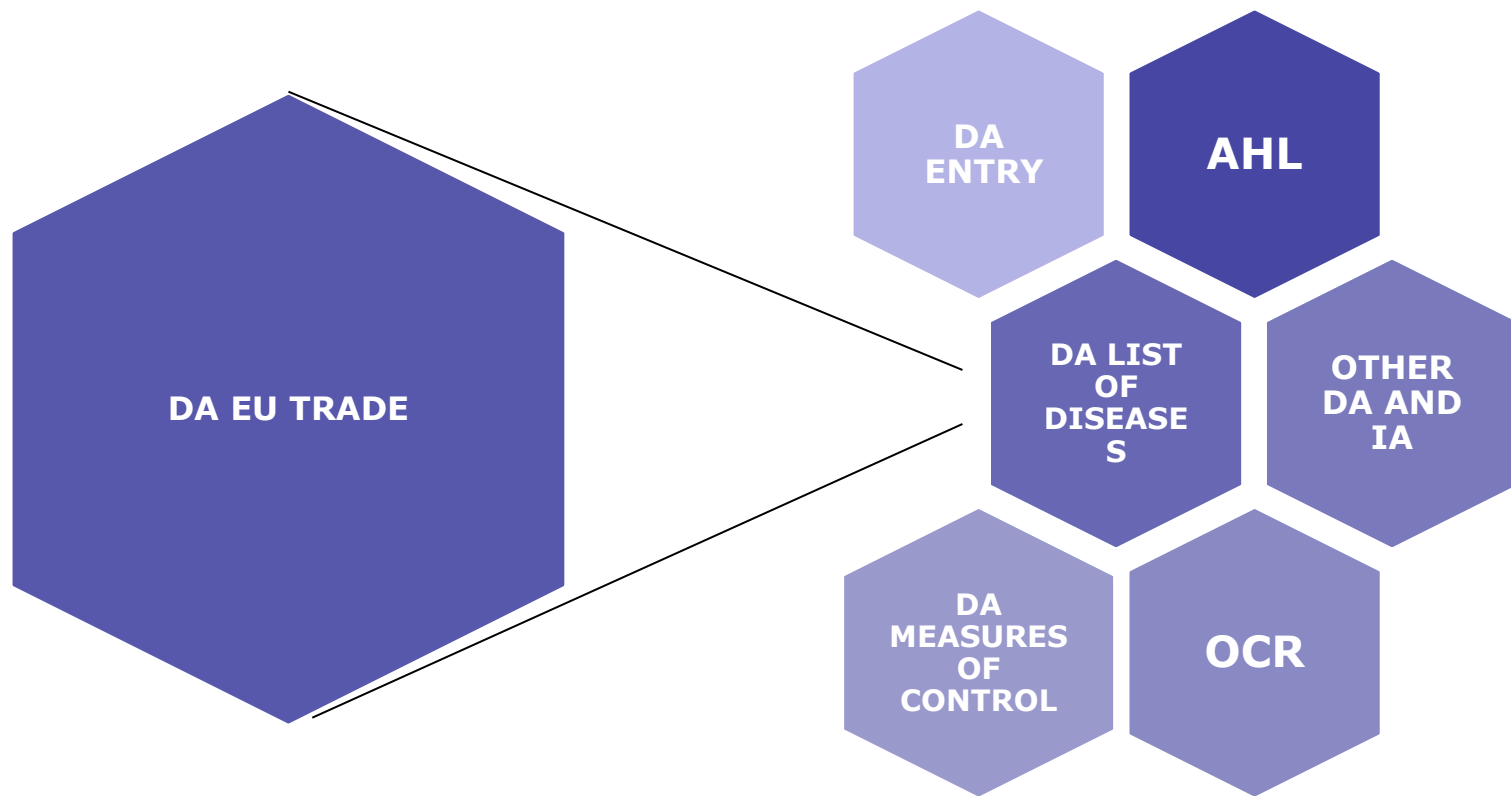


APPROACH TO NEW LEGISLATION

FUTURE DELEGATED REGULATION'S STRUCTURE

Part I: Subject, scope, definitions and general provisions

Part II: Movement within the Union of terrestrial animals

Chapters: Ungulates, poultry, captive birds, other kept terrestrial animals, assembly operations, confined establishments, certification and notification

Part III: Final provisions



NEW PROPOSALS and MAIN CHANGES

!DO NOT CHANGE WHAT WORKS WELL!

Terrestrial animals: Ungulates (except *Equidae*)

- ✓ Update of the requirements to the new EU list of diseases:
 - ✓ New requirements for "C" and "D" diseases
 - ✓ B diseases: TB (**complex**), Brucellosis (**complex**)
 - ✓ C diseases: **EBL**, **BT**, IBR, **BVD**, AD
 - ✓ D diseases: EHD, Surra, *B. ovis* (sheep), TB (goats), *B. suis* (outdoor pigs)
 - ✓ *Camelidae* and *Cervidae*
 - ✓ D diseases: TB (complex), Brucellosis (complex), EHD (deer), surra (camelidae)
- ✓ Disease free status at the level of establishment ("holding" instead of epidemiological unit ("herd"))



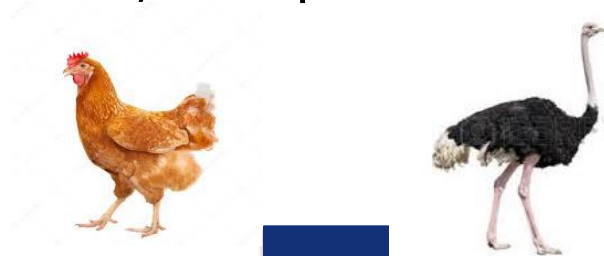
Terrestrial animals: *Equidae*

- ✓ Update of the requirements to the new EU list of diseases:
 - ✓ Deleted: freedom of the establishment for 6 months of equine encephalomyelitis of any type for which equidae are dead-end hosts
 - ✓ Added: Surra
- ✓ *Specific conditions for equidae with a higher health status*



Terrestrial animals: Poultry and captive birds

- ✓ Poultry vs captive birds, i.e. chicken kept hobby/shows
 - ✓ **certification of captive birds**
 - ✓ **Pre-movement checks day-old-chicks – under discussion**
- ✓ HPAI, LPAI and NcD in DA on Surveillance
- ✓ Salmonella + Mycoplasma surveillance in DA on approval, not for poultry for slaughter, pre-movement testing for <20
- ✓ H5/H7 pre-movement testing for game supply + outdoor-poultry and ducks/gees
- ✓ ID of ratites
- ✓ SPF eggs: certificate, European Pharmacopeia.



Continued need for discussion:

- ✓ Assembly operations (traceability, duration of assembly operation in line with other EU legislation on movement of animals)
 - ✓ **Request of experts for definition of assembly centres and dealers premises different rules for assembly**
- ✓ Certification: rules for and exemptions from certification (e.g. agreements on movement of horses)
- ✓ Movement into confined establishments
- ✓ Movements of bees and bumble bees
- ✓ Movement of wild animals

Delegated act:

- ✓ Expert-Group meetings with Member States
- ✓ Public consultation

Implementing acts:

- ✓ SCoPAFF
