Implementing and delegated acts for applying the EU plant health regime

PLANT HEALTH REGULATION (EU) 2016/2031

OFFICIAL CONTROLS REGULATION (EU) 2017/625 All essential delegated and implementing acts are in place

Complementary acts adopted in 2021 and 2022

Food Safety



Plant Health Regulation High risk plants

Commission Implementing Regulation (EU) 2018/2019

Receiving dossiers from non-EU countries to make the full risk assessment

by November 2023: <u>92 dossiers received</u>

90 accepted as 'complete' at COM level and 53 assessed by EFSA

38 finalised with

- Implementing Regulations amending Regulation (EU) 2018/2019
- Implementing Regulation (EU) 2020/ 1213 + amendments with specific requirements for specified plants from specified countries



Plant Health Regulation

Annexes of Implementing Regulation (EU) 2019/2072

- Implementing Regulation (EU) 2019/2072 contains 14 technical Annexes listing regulated pests, measures on commodities and rules on certification
- A new comprehensive review is being prepared
- A draft amendment of the Annexes has been submitted for consultation under the WTO/SPS procedure

Official Controls Regulation

Frequency of import checks

Art.54.3 OCR frequency of import checks

- Adoption of Commission Implementing Regulation (EU) 2024/591
- 100% controls on plants for planting and plants/plant products / other objects subject to the special measures of Art. 28 and 30
- Reduced frequencies for 53 commodities (cut flowers, fruits, vegetables, used machinery) listed in the Annex on the basis of new data of interceptions





Plant Health Regulation

Commission proposal for amendment of Regulation (EU) 2016/2031

Commission proposal to amend several provisions of Regulation (EU) 2016/2031 - COM(2023) 661 final

It introduces rationalisation and reduction of reporting obligations, amendments of import rules, clarification of legal bases for temporary measures, empowerments to establish procedures for high risk plants, temporary derogations and movement of plants without attaching plant passports

It was voted by the plenary session of the European Parliament on 24 April 2024.

To be published and enter into force in autumn.
