

Epidemiological Situation in Greece

- No outbreaks confirmed in Greek territory.
- 209 outbreaks in neighboring Bulgaria (165 outbreaks in wild boars, 44 outbreaks in domestic pigs (14.1.2020 ADNS data).
- On 24th of October 2019: confirmed outbreak of ASF in a wild boar found dead near Greek-Bulgarian borders.

Surveillance of ASF - Greece

2019-2020 (data until 14.1.2020)

Passive surveillance

- ✓ 11 wild boars found dead
- √ 5 Backyard pigs
- ✓ 1 pig from commercial farm (slaughterhouse)
- ✓ 1 pig found dead (Evros RU, unknown owner)

Active surveillance

- ✓ 22 hunted wild boars (in Xanthi, Evros, Drama, Thessaloniki Regional Unit)
- ✓ 3 Free range pigs
- ✓ 152 pigs of backyard & commercial farms in Part 1 areas in Greece and other RUs

Missions

of hunters/gamekeepers conducted at the end of 2019 in the area where increased measures are applied following the outbreak in Bulgaria (24.10.2019):


No dead wild boars have been detected






Surveillance of ASF in domestic pigs (2019-today)

High Risk areas in Drama and Xanthi Regional Units

Hunting	Ban of activities within the Area II (except for wild boar intensive hunting). By derogation hunting of other species may be conducted following special permission by the Local Veterinary Service. Proper management of wild boar meat and carcasses.	
Forestry activities	Ban of activities. By derogation forestry activities may be conducted following special permission by the Local Veterinary Service.	
Farms	 Ban of live pigs movements and movements of pig products. By derogation, some movements can be allowed following special permission by the Local Veterinary Service. Clinical examination of pigs and controls regarding biosecurity measures along with sanctions in case of non -compliance(commercial and backyards farms). 	
Type of surveillance	Passive: Sampling of all wild boars found dead for laboratory examination. Sampling of all pigs found dead or sick in every pig holding. Active: Sampling of hunted/shot animals for laboratory examination(depending on laboratory capacity). Sampling of all backyard pigs and specific number of pigs in commercial holdings.	
Duration of measures	•1 year following the ASF case in Bulgaria based on the epidemiological situation.	
Other measures	Awareness campaign. Placement of informative signs across the area Compensation of 50E for each wild boar found dead and buried for hunters/game keepers. Consideration to provide additional remuneration of 100 EURO for hunters for each wild boar hunted	

Additional Preparation Measures (apart from that provided in our presentation on 21.11.2019)

- Meetings/training courses including all stakeholders (scheduled for 2020)
- Army collaboration: A draft of Ministerial Decision for the assistance of veterinarians for ASF control measures implementation of the Army has been issued
- Supervision by the CCA of the controls conducted by the seasonal staff recruited for ASF in different Regional Units of the country – circulars issuance if required
- A second lab in the Directorate of Veterinary Center of Thessaloniki is being prepared for accepting and analyzing ASF samples (training of veterinarians, lab reagents-consumables purchase, equipment maintenance etc)
- Other: Tender for consumables for ASF sampling is to be finalized in the following period — A new circular regarding coding for ASF samples sent to the lab has been distributed - Actions for recruitment of seasonal staff in the NRL

Controls – clinical tests – biosecurity (seasonal staff recruited for the needs of ASF preventive measures)
