B.04 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Commission Implementing Regulation (EU) 2022/478 on maintaining protective measures on imports of bivalve molluscs from Türkiye intended for human consumption. (JB)

The purpose of this Regulation is to maintain protective measures on imports of bivalve molluscs from Türkiye intended for human consumption, by prolonging Commission Implementing Regulation (EU) 2022/478. Due to the safeguard measure, Türkiye is, as of 2013, no longer allowed to export fresh and chilled bivalve molluscs to the EU whereas frozen and processed bivalve molluscs imported from Türkiye are subject to certain import controls. Recent Commission audits from 2021-2022 and 2023 found that certain deficiencies in the control system for bivalve molluscs had not been resolved. Lifting the measures would therefore not be justified.
