



#### ASF outbreak in WB in previously free zone







- ASF outbreak has been notified by ADIS with Ref. No. <u>PL-ASF-2024-00668</u>.
- Disease was detected on <u>24<sup>th</sup> April 2024</u> on the basis of positive test RT-PCR result obtained in the samples collected by local veterinary CA from dead wild boars (female, 24 months old and 9 piglets), which were found in city of <u>Gdynia</u>, in pomorskie voivodeship.
- The distance of detection new primary ASF outbreak in wild boar is approx. 60 km from the RZ I established in pomorskie voivodeship.




### Infected zone

Until today – 6 outbreaks in WB in the city of Gdynia - Karwiny i Wielki Kack at Eastern side of road S6.






### Actions taken in response to the outbreak



- On 26<sup>th</sup> April 2024 odour barrier was prepared, which strenghthened the barrier of S6 road (fenced expressway) - prevention of WB migration.
- DVO in Gdynia established infected zone and also implemented control measures in the city of Gdynia (testing all shot and dead WB for ASFV, rules for managing shot and dead WB, restrictions on collective hunting and prohibition of entering the forests in Karwin and Wielki Kack, which are neighborhoods of the city of Gdynia).
- Sealing the fences and odour barrier along the entire section of **Tricity Ring Road**.
- Cooperation with farmers,
- Awarnes campaign,
- Preparing document "Disease eradication action plan" dedicated for all veterinary competent authorities and stakeholders.





### Actions taken in response to the outbreak





- Active searches of dead wild boars or their remains.
- Sanitary shooting.
- Trapping WB with culling on the basis of DVOs regulations in the cities, where there is no option for hunts or sanitary shooting.

#### ON THE EAST SIDE OF THE S6 ROAD

- Ban on collective hunting in the area of Gdynia
- Reduction of wild boar through individual hunting
- Access to forests is prohibited
- Organization of collection and transport for disposal of dead wild boars
- Preparing pig farms for enforced biosecurity measures

ON THE WEST SIDE OF THE S6 ROAD

- Intensive hunting
- Maximum reduction of WB population along the <u>Tricity Ring Road</u>
- Preparation of infrastructure for WB testing
- Preparing pig farms for enforced biosecurity measures
