Operators' rights – SEO, Art. 35, 36, 69 OCR

Second expert opinion

Operators, whose animals or goods are subject to "sampling, analysis, test or diagnosis" have the right to a second expert opinion:

documentary review and/or

second analysis and

third analysis in case of dispute, **if** implemented in national law



Operators' rights – SEO, Art. 35, 36, 69 OCR

Second expert opinion

sector specific rules prevail

'relevant, appropriate, technically feasible'

elimination and containment of risks precede the right [Art. 35(4)]

History of compliance [Art. 44]

Minimum burden – place of controls [Art. 44]

Authenticated or electronic copy of official certificates and docs [Art.50]

Upon measures, to consider operator's views if no risk [Art. 66]

Listing

Lists or registers

Name, legal form, activities, places

Areas under the OCR scope

Operators' obligations – Art. 15(5), 36 OCR

e-commerce

Same principles in e-commerce activities

Listing: info on channels of distance communication (e.g. social networks), to permit OCs

DSA [Digital Services Act (EU) 2022/2065]: very large online platforms and search engines.

Intermediary service providers – hosting: certain actions, "compliance by design"

Regulation (EU) No 1169/2011: Fair commercial practices



Operators' obligations – animals and goods

entering the Union

Use of CHED and prior notification (Part I) [Art. 47]

Correct CN codes

Access equipment, means of transport, premises, IMS, animals and goods, docs, information [paper, electronic] [Art. 15]

Presentation of a duly finalized CHED to the customs [Art. 57]

Taking of measures [Art. 66, 69], arrangements for re-dispatch [Art. 72]



Operators' obligations – official certification

Official certificates

Facts and data from own control systems Regular official controls [Art. 88]

Official attestations

Supervision of operators issuing official attestations [Art. 91]



Operators' obligations – Art. 79,81,82

mandatory fees

- Consignments of animals and goods of Art. 47 (1), (a), (b), (c)
- Activities of Chapter II of Annex IV

Fixed amounts of Annex IV

OR

Calculation of Art. 82 (1)

- Consignments of animals and goods of Art. 47 (1), (d), (e), (f)

- At operator's request to obtain approval of Art. 1- Reg. (EC) 183/2005

- Not planned, following non-compliance

Calculation of Art. 82 (1)


Flat rate based on overall costs
