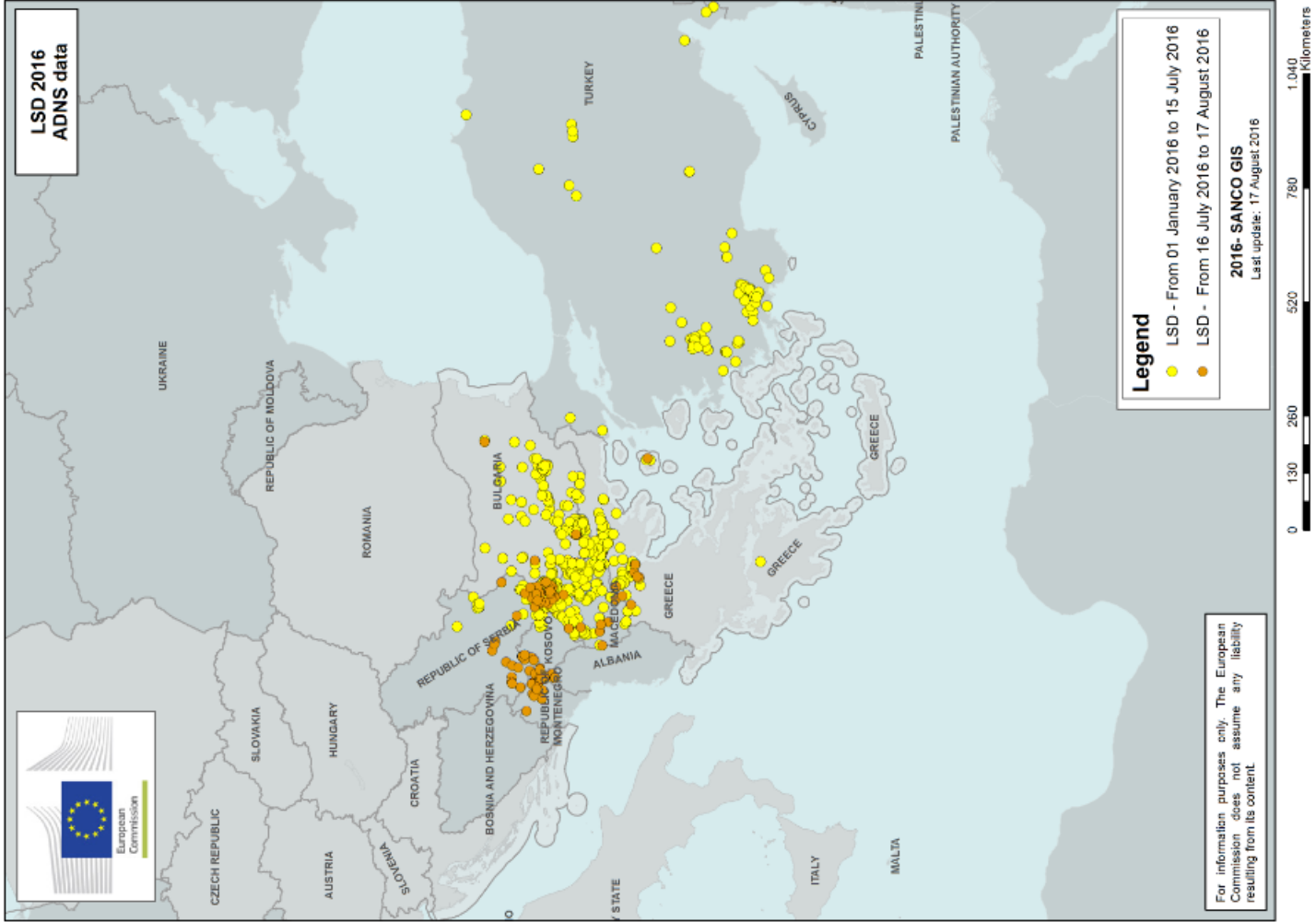

Operational since April 2016 with an initial capacity of 400.000 now extended with an additional 200.000 doses (since June 2016).
