



Bovine Tuberculosis: history

OTF withdrawn 2001-2014



Tuberculosis: surveillance

SICCT

1973 -2001: In accordance with 64/432; reduced to every four

years in 1982. Pre-import SICCT from 1999 (UK animals)

2001-2007: Annual testing of importing herds: Biennial testing of all other

herds. 60 day post-import SICCT introduced

2007-current: All herds placed on biennial testing following introduction of

γIFN for imported animals in addition to SICCT

Post mortem

All slaughtered bovines are subjected to official post-mortem at meat inspection

Any reactor, or suspect finding, results in an epidemiological investigation; together with submission of samples to APHA Weybridge laboratory for culture and subsequent typing

Having accounted for introduced infection:

The percentage of bovine herds confirmed as infected with tuberculosis has not exceeded 0.1% per year of all herds for six consecutive years, and at least 99.9% of herds have achieved officially tuberculosis-free status each year for six consecutive years

Conclusion

- The cases of bovine tuberculosis identified since 2001 can be shown to have been introduced and have neither established, nor recrudesced.
- The importation of bovines into the Isle of Man is subject to certification and authorised only from OTF herds in EU Member States.
- There is both active and passive surveillance for bovine tuberculosis.
- Since the last OTF "status withdrawn" in April 2009, all farms have maintained their OTF status, or re-achieved from "suspended" within the year.
- There is statutory legislation for bovine tuberculosis and for bovine identification in accordance with current EU legislation.

Therefore, the IOM requests to be declared by the EU as an officially tuberculosis free region of the United Kingdom (UK)
