




- numbers of dead found wild boar in the District Zlín (in total 262)

# Findings of dead wild boars – cumulative incidence


numbers of dead found wild boars in the District Zlín (in total 262) numbers of ASF positive wild boars (in total 112)










#### Hunted wild boars in infected area – 23th October

#### The total number 1005

All hunted wild boars are tested for ASF (virologically and serologically) in the NRL. Only 1 case of wild boar caught in trapping facility in hunting area Lužkovice was positive.



# Aims of the eradication plan according CD 2002/60/EC


- To prevent spreading of disease in wild boars population;
- To prevent introduction of disease to domestic pigs holding;
- To reduce the wild boars population;
- Eradication of African swine fever (ASF) in wild boars population in the infected area

#### Demarcation of the infected area



In accordance with the Council Directive 2002/60/EC the whole District Zlín has been declared as an infected area (1 034 km²), 37 municipalities, 89 hunting grounds






# Density of domestic pigs in the Czech Republic (per 100 km²)

Region of Zlín 83 farms, 74 088 pigs





# Modelled wild boar population density in Europe (source: FAO/ASFORCE, May 2015)






# Veterinary measures have been taken in accordance with the Council Directive 2002/60/EC:

- Infected area has been defined
- Veterinary measures have been established, including ban of hunting and a ban on feeding wild boars
- Investigation of the epidemiological situation is carried out in the whole defined infected area
- The official list of all categories of domestic pigs in all holdings was ordered
- The area with intensive hunting has been determined around the infected area



# Measures in Wild boar population in 4 levels





#### Measures taken

- 1. Measures in the infected area in domestic pigs
- 2. Measures in the infected area in wild boars
  - in the high-risk zone
  - in the low-risk zone
- 3. Measures in the area with intensive hunting
- 4. Measures on the whole territory of the Czech Republic



## Measures in the infected area in domestic pigs

- 1. Official checks in domestic pig farms
- 2. Monitoring of all sick or dead pigs
- 3. A list of pig farms in the infected area including backyards farms
- 4. Movement control
- 5. Ban of feeding with fresh grass
- 6. Ban of straw using
- 7. Measures of biosecurity in backyard farm (pigs for home slaughter)



#### Measures taken in the infected area after ASF confirmation

- 1. Passive surveillance in dead wild boars
- 2. Payment is 1000 CZK (40 EUR) for one dead found wild boar
- 3. Ban of hunting
- 4. Ban of feeding
- 5. Ban on feeding of wild boars, only baiting can be performed with not more feeding than 10 kg / month / 1 km², it is not applicable for hunting using trapping facilities;
- 6. Smell and electric fences around the high-risk zone
- 7. The ban on public entering to the high-risk zone
- **8.** Unharvested crop as a shelter for wild bar in selected areas (maize, rape, cron)










# Map of the high-risk zone with the location of the smell fences and electric fences







# Setting up high and low risk zone in the framework of infected zone in relation to wild boar hunting

#### Hunting


Home range – 100% one year

# Measures in the infected area in the high-risk zone in wild boars

- RED zone area around the outbreak has been set as "off-limit area". (18 hunting areas 16 000 hectares). Wild boar individual hunting activities have been banned till 11. 9. 2017.
- Trapping of wild boars has been alovend since 24. 8. 2017.
- Public is not allowed to enter this area apart from farmers, hunters and police.
- All collective hunts (even for other hoofed game) have been banned.
- Motivation for finding dead wild boar is 4 000 CZK / 160 €.



# Measures in the infected area in the high-risk zone in wild boars

- hunting of wild boar is allowed only for selected and trained hunters, motivated by financial compensation (4 000 CZK/ 160 € each hunted wild boar). The same compensation is for trapping.
- all hunted and found death wild boar must be disposed in the rendering plant.
- Hunters assicioation is compensated for the loss of venison (piglet 37 EUR, one-year old 74 EUR, adult saw 120 EUR).

# Measures in the infected area in the low-risk zone in wild boars (green zone)


- hunting of wild boar is allowed since 21. 7. and motivated by financial reward (3 000 CZK/ 120 € each hunted wild boar) - all shot and found wild boar must be disposed in the rendering plant.
- compenzation for the loss of venison (piglet 37 EUR, one-year old 74 EUR, adult saw 120 EUR) is paid to hunters association.
- All collective hunts (even for other hoofed game) are banned.
- Motivation fee for finding of dead wild boar is 3 000 CZK / 120 €.
- Some prohibited methods of hunting have been allowed hunting all age classes, and both sexes, hunting from cars and other vehicles, hunting at night using night vision and other artificial lights, hunting during crop harvest, hunting near the hunting area borders, using firearms (short and long with energy more than 300 J) for shooting wild boar in traps.

# Disposal of hunted wild boars from infected area in rendering plant













## Measures in the area with intensive hunting

- 1. Buffer zone area of intensive hunting surrounding the infected area, hunters are motivated by 1 000 CZK (40 €) for each shot wild boar.
- 2. The shot wild boar can be used for consumption.
- 3. Some prohibited methods of hunting have been allowed hunting all age classes, and both sexes, hunting from cars and other vehicles, hunting at night using night vision and other artificial lights, hunting during crop harvest, hunting near the hunting area borders, using firearms (short and long with energy more than 300 J) for shooting wild boar in traps.
- 4. Motivation for finding of dead wild boar is 1 000 CZK / 40 €



## Measures on the whole territory of the Czech Republic

- 1. Information for public, pig farmers, hunters, veterinarians etc.
  - Official letters
  - Daily SVA web site updates
  - Biosecurity guide for farmers
  - List of disinfectants
  - Guide for dead WB finding
- 2. Established an expert group (NDCC) including veterinarians, hunters, wild life biologists and epidemiologists with expert from the CVET participation
  - Clarifying of the situation
  - Request for data for the preparation of the eradication plan
  - Studying the epidemiological situation and implementation of the measures
- 3. Ban of feeding of domestic pigs with kitchen and catering waste was emphasized
- 4. A surveillance programme and preventive measures have been applied at holdings with domestic pigs. Sick or dead pigs, for which ASF cannot be excluded on clinical grounds, have been tested for ASF in accordance with the provisions set up in the Diagnostic Manual
- 5. The passive surveillance of dead found wild boars continues



# Hunting in the rest areas of the Czech Republic


- Hunting is also intensified.
- Some prohibited methods of hunting have been allowed hunting all age classes, and both sexes, hunting at night using night vision and other artificial lights, hunting during crop harvest, hunting near the hunting area borders, using firearms (short and long with energy more than 300 J) for shooting wild boar in traps.
- Motivation for finding dead wild boar is 1 000 CZK (40 €).

## Collection of death wild boar – paid to hunters

CZ	1 000,00 CZK / 40 €
Infected zone – low risk (green)	3 000 CZK / 120 €
Infected zone – high risk (red)	4 000 CZK / 160 €
