The purpose of this draft is to amend the model of certificate for imports of dogs, cats and ferrets in order to provide better guidance for certifying officials with regard to the verification of the authenticity of the laboratory report on the results of the rabies antibody titration test.

**B.03** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Decision 93/195/EEC as regards animal health and veterinary certification conditions for the re-entry of registered horses for racing, competition and cultural events after temporary export to Mexico and the United States of America, and amending Annex I to Decision 2004/211/EC as regards the entry for China and Mexico in the list of third countries and parts thereof from which imports into the Union of live equidae and semen, ova and embryos of the equine species are authorised. (AEF/EC)

The equestrian events of the LG Global Champions Tour will take place in Miami and in Mexico-City during the period 30 March to 30 April 2017 and in Shanghai during the period 20 April to 20 May 2017. The scope of this Decision is to amend the list of third countries from which re-entry into the Union of registered horses for racing, competition and cultural events after temporary export is authorised. It will also introduce minor modifications in the existing specific health certificate for re-entry. The objective is to allow horses which participate in these events returning to the EU after the event. This is possible since the venue in Shanghai is a purpose-built temporary construction and in Mexico the event takes place during the vector low season so less chance of infection. Because the exact dates of the competitions in Mexico and Miami are still to be agreed by FEI it is also necessary to allow the use of the certificate independently from the sequence of the equestrian events.

**B.04** Exchange of views of the Committee on a draft Commission Regulation amending Regulation (EC) No 2074/2005 as regards the official controls on fishery products caught by Union flagged vessels and introduced into Union territory after being transferred in non-Union countries and establishing a model of the health certificate for those products. (PC/PL/BS)

The draft Regulation establishes the hygienic rules for fishery products caught by Union vessels, which are unloaded – with or without storage in cold stores – in non-Union countries before their final movement to the Union. It lays down a simplified model health certificate for these fishery products with the sanitary conditions for these fishery products, which has to be issued by the relevant non-Union country. The draft Regulation harmonising the import conditions should go together with the draft Decision derogating from full import controls in BIPs for Union fishery products (SANTE/10576/2016).

**B.05** Exchange of views of the Committee on a draft Commission Implementing Decision as regards fishery products caught by Union Member State's flagged vessels and entering the Union territory after being transferred in non-Union countries. (PC/PL/BS)

The draft Decision derogates from full import controls in Union border inspection posts (BIPs) for fishery products caught by Union vessels, which are unloaded – with or without storage in cold stores – in non-Union countries before their final movement to the Union. For such products only a documentary check needs to be carried out at the BIP of entry to verify that they are originating from Union vessels and that no processing took place in the non-Union country in which they were unloaded. Therefore, and to harmonise import controls, it lays down that the simplified model health certificate proposed in the draft Regulation SANTE/10575/2016 needs to be checked

This measure allows for a simplified procedure for the listing of Canadian establishments that produce products for which equivalence has been established under the EU-Canada Veterinary Agreement. The new procedure foresees in an amendment to the procedure laid down in article 12 of Regulation (EC) No 854/2004 and is conformable to the procedure endorsed last year for New Zealand establishments under similar conditions by Commission Implementing Decision 2015/1084.
