This Implementing Regulation is based on the Animal Health Law, the Animal Breeding Regulation and the Veterinary Medicines Regulation. It will set out the rules related to the system for identification and registration of equidae (horses). It will lay down the model identification document for equidae (the equine passport) which will provide identification of the animal, document its food producing status, will serve as zootechnical certificate for breeding purposes and will contain information necessary to compete or race.

It will essentially replace Implementing Regulation (EU) 2015/262 and become applicable on 21 April 2021. However, following the adoption of Regulation (EU) 2019/6, which will be applicable on 28 January 2022, the part of the proposed Implementing Regulation which will contain the new model identification document should only be applicable as of that date.
