## <u>14 June 2024</u>: Information event for stakeholders on foreseen Regulatory changes to FCM legislation ahead of the revision of Regulation (EC) No 1935/2004

Dear Stakeholders,

On Friday morning 14 June 2024 we will organise a stakeholder event to explain the main on-going legislative work in the food contact sector.

This event will cover:

- the new Regulation on BPA (vote in SC-PAFF foreseen 12 June).
- the quality amendment to Regulation (EU) No 10/2011, Regulation (EU) 2022/1616 and Regulation (EC) No 2023/2006 (vote foreseen in September).
- several on-going matters under Regulation (EU) 2022/1616 on plastic recycling, including a foreseen amendment, the register, novel technologies and recycling schemes, and the authorisation decisions which are expected to be notified around the summer.

We will provide a 30 minute introduction on each of these three topics, during which time the FCM team will explain the outstanding issues and try to clarify as many points as possible. Each explanation will be followed by a 30 minute Q&A session which is to provide you with an opportunity to have your questions answered. Please follow the rules as indicated on the agenda.

The meeting will be held in the Conference Centre Albert Borschette, in Brussels and online. For physical participation in the room: European Professional associations and NGOs (and Member States) **must register by 3 June** at the latest. For this group a maximum of 50 seats will be available. The maximum number of participants will be two per association. In case of high interest, we may allocate only a single or no seats to associations for which we consider participation less relevant. From 4 June onwards we will allocate a maximum of 18 individual participants in principle on a first come – first serve basis based on an expression of interest to ensure a distribution of interests. We may refuse participation if we see fit.

Online participation is unlimited, but in all cases when you want to register, please send an e-mail to <u>SANTE-FCM-CONSULTATIONS@ec.europa.eu</u> either by 3 June 17:00 (*later e-mails will not be accepted*) if you are an association or NGO, or after 4 June 09:00 (*earlier e-mails will be ignored*) if you want to participate as an individual. We will inform you on 6 June as to whether you are permitted access to the room for the event. Please clearly describe why it is important for you to participate in the room, justify why you need participation with two persons (if so), provide your <u>transparency register number</u> (only if registering by 3 June), and provide your name and e-mail address to prepare for your entrance pass (V-Pass), which you will need to bring with you on the day of the meeting. Kindly note that travelling and accommodation costs <u>are not covered</u> by the European Commission.

On-line presentation will be limited only by our ability to register you. Registrations for on-line participation after 11 June may not be accepted.

Documents will be provided ahead of the meeting to registered participants if these are available.
