SUMMARY REPORT

A.01 General information by third countries.

A.02 Information from the Commission on the modality (physically presence / remote) of the meetings of the Standing Committee on Plants, Animals, Food and Feed.

Member States were informed that the June PAFF will be planned a physical presence only meeting and that efforts would be made to alternate physical presence meetings with remote (INTERACTIO) meetings (all subject, of course, to the Covid situation across the Union). This arrangement is initially for the remainder of 2022 and will be reviewed at the end of the year.

A.03 Information point on import-export issues between the EU and UK (GB).

The Commission provided clarifications to Member States with regard to the scope of the latest postponement to implementation of SPS import controls for certain products imported into Great Britain from the EU, announced by the UK Government on 28 April 2022.

B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation (EU) amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry, germinal products of poultry and fresh meat of poultry and game birds.

Regular update of the HPAI regionalisation in Canada, the UK and the US. No comments were raised by Member States

Outcome of the vote by written consultation: Favourable opinion.

B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Decision 2011/163/EU on the approval of plans submitted by third countries in accordance with Article 29 of Council Directive 96/23/EC.

B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending and correcting Annex IX to Implementing Regulation (EU) 2021/405 as regards the lists of third countries or regions thereof authorised for the entry into the Union of certain fishery products.

The Commission provided the state of play regarding the planned amendment of CID 2011/163/EU which is planned to be presented for discussion and possible opinion at the next PAFF Committee.
