SUMMARY IN 2024

a total of 5 outbreaks of HPAI in poultry, 18 outbreaks of HPAI in captive birds and 5 HPAI cases in wild birds

CURRENT SITUATION

5 new HPAI outbreaks in poultry, 5 new HPAI outbreaks in captive birds and 5 new cases in wild birds since the last SCoPAFF meeting on 23 January 2024

5 HPAI H5N1 outbreaks in commercial holdings in two regions:

- Pardubice Region (2 outbreaks)
- Vysočina Region (3 outbreaks)



Situation in poultry

5 new outbreaks HPAI H5N1 in commercial poultry holdings :


- No. HPAI-1/2024 confirmed on 30 January 2024, *Pardubice Region*, 70 000 breeding commercial flock
- No. HPAI-2/2024 confirmed on 2 February 2024, *Pardubice Region*, 20 000 breeding commercial flock
- **No. HPAI-3/2024** confirmed on 4 February 2024, *Vysočina Region*, 50 000 fattening ducks
- No. HPAI-4/2024 confirmed on 14 February 2024, Vysočina Region, 11 672 breeding commercial flock
- No. HPAI-5/2024 confirmed on 14 February 2024, *Vysočina Region*, 45 000 rearing flock
- poultry and poultry products for commercial use
- a higher mortality of birds, clinical sings
- culling of all remaining birds on affected holdings, disposal of carcasses and poultry products, preliminary cleaning and disinfection
- restricted zones established around all outbreaks all measures in the protection and surveillance zones are implemented in compliance with the Commission Delegated Regulation (EU) 2020/687

<u>Source of infection:</u> wild birds suspected (epizootological investigation is ongoing)




Situation in poultry

5 new outbreaks HPAI H5N1 in commercial poultry holdings :

Situation in captive birds

5 new outbreaks HPAI H5N1 in backyards:

- No. HPAI2-14/2024 confirmed on 5 February 2024, Central Bohemian Region, 16 birds (laying hens)
- No. HPAI2-15/2024 confirmed on 5 February 2024, Central Bohemian Region, 48 birds (laying hens, geese, ducks)
- No. HPAI2-16/2024 confirmed on 13 February 2024, South Moravian Region, 33 birds (laying hens, geese, ducks)
- No. HPAI2-17/2024 confirmed on 9 February 2024, Central Bohemian Region, 9 birds (laying hens, ducks)
- **No.** HPAI2-18/2024 confirmed on 14 February 2024, *Vysočina Region*, 15 birds (laying hens)
- All poultry keepers and municipalities in radius 10 km around outbreak were informed immediately.
- All these outbreaks involve backyard holdings with not more than 50 susceptible animals and with products intended for private use only
- All captive birds in outbreaks were culled
- Carcasses and products were safely disposed of in a rendering plant
- Preliminary cleaning and disinfection were carried out immediately



Situation in captive birds

- Protection and surveillance zones (3 and 10 km) were not established
- Final cleaning and disinfection are carried out in the outbreak site and then starts a monitoring period of 21 days

Source of infection: wild birds suspected (outdoor keeping, direct/indirect contact with wild birds can not be excluded)



Situation in wild birds

5 cases HPAI H5N1 in wild birds, 12 PCR tests performed:

- **No. HPAI3-1/2024** confirmed on 25 January 2024, *South Bohemian Region*, finding the carcass of a mallard
- **No. HPAI3-2/2024** confirmed on 25 January 2024, *South Bohemian Region*, increased mortality of waterfowl gooses approx. 25 pcs, heron, swan, mallard
- No. HPAI3-3/2024 confirmed on 2 February 2024, South Moravian Region, increased mortality of mute swans (15 pcs)
- No. HPAI3-4/2024 confirmed on 9 February 2024, *Hradec Králové Region*, increased mortality of mute swans (20 pcs)
- No. HPAI3-5/2024 confirmed on 9 February 2024, South Bohemian Region, increased mortality of waterfowl (1x mallard, 2x gooses)
